



The tables below illustrate the voting results for the Behavioral Health and Care Coordination measures, which the CSAC voted on endorsement following the June 21, 2017 conference call. Votes were received from 16 out of 17 CSAC members. The CSAC decisions regarding measure endorsement are final, without ratification by the NQF Board of Directors. The NQF 30-day appeals period for the endorsed measures opened on July 3, 2017 and will close on August 2, 2017.
