Thomas McInerny, MD (Co-Chair) Associate Chair for Clinical Affair, Dept. of Pediatrics University of Rochester

Thomas McInerny, MD, is professor of pediatrics and associate chair of clinical affairs in the department of pediatrics at the University of Rochester Medical Center. Over the past 38 years, Dr. McInerny has authored or co-authored over 30 articles and is the editor-in-chief of the American Academy of Pediatric's (AAP) *Textbook of Pediatric Care* and *Pediatric Care Online*. He has been a member of AAP's Steering Committee on Quality Improvement and Management for three years. Dr. McInerny is a graduate of Dartmouth and Harvard medical schools and received his pediatric training at Children's Hospital Boston and Children's Hospital Cincinnati.

Ms. Sarah S. Brown, MSPH CEO The National Campaign to Prevent Teen and Unplanned Pregnancy

Sarah S. Brown is co-founder and CEO of the National Campaign to Prevent Teen and Unplanned Pregnancy, a non-profit organization designed to catalyze and support actions nationwide to prevent teen pregnancy as well as unplanned pregnancy among single young adults. Before helping to found the Campaign in 1996, she was a senior study director at the Institute of Medicine, where she directed numerous studies in the broad field of maternal and child health. She has served on advisory boards of a number of organizations, including the Guttmacher Institute, American College of Obstetrics and Gynecology, National Academy of Sciences, March of Dimes, and the David and Lucille Packard Foundation. She appears often in print, broadcast, and online media, and is the author of numerous research papers.

Ms. Carroll Carlson, RN, BSN Director-Government Programs Group Health Cooperative of Eau Claire

Carroll Carlson has over twenty years experience in the health insurance field. She serves as Director of Government Programs for Group Health Cooperative of Eau Claire. The Cooperative provides health care coverage to employers and individuals in western Wisconsin, Wisconsin BadgerCare Plus and Medicaid SSI enrollees (Medicaid programs) and also administers the Compcare BadgerCare Plus program. Dr. Alex Y. Chen, MD, MS Associate Professor of Clinical Pediatrics

Keck School of Medicine

Alex Y. Chen is an academic general pediatrician and a health services researcher. He is currently an Associate Professor at Childrens Hospital Los Angeles, University of Southern California Keck School of Medicine. He graduated from Harvard Medical School in 1997, completed his residency in Pediatrics, and was selected as a Robert Wood Johnson Clinical Scholar in 2000. Dr. Chen's primary research interests are in the area of healthcare access and quality. He received a five-year research career development award (K23) from the National Institutes of Health to examine issues related to healthcare access among children with chronic illnesses, particularly minority and immigrant children. He also received a three-year independent scientist award (KO2) from the AHRQ to develop quality indicators for primary care of complex pediatric patients and currently collaborates with Drs. Mangione-Smith, McGlynn, and Britto on an NHLBI-funded R01 to develop measures of health care quality for inpatient pediatric respiratory illnesses. He continues to practice general pediatrics and he is a member of the CHLA committee that develops evidence-based best practice guideline (Medical Action Plan) for key pediatric conditions. He is also an advisory committee member on Quality for the California State Children's Health Insurance Program (SCHIP-Healthy Families).

Dr. David R. Clarke, MD Clinical Professor of Surgery

The Children's Hospital

David Clarke has dedicated his extensive 30-year career to the care of infants and children with congenital heart disease, and currently serves as Clinical Professor of Surgery at the University of Colorado Denver. He played an integral role in the project that yielded the development of the Aristotle Complexity Score, a complexity-adjusted method to measure surgical performance in congenital heart surgery. He is a member of 17 national and international scientific organizations and associations. In addition, Dr. Clarke serves on the Society of Thoracic Surgeons (STS) Congenital Heart Surgery Database Task Force and has chaired its Data Verification Subcommittee since 2004.

Dr. Sharron L. Docherty, PhD, CPNP (AC/PC) Associate Professor, Pediatric Acute/Chronic Care, Specialty Director National Association of Pediatric Nurse Practitioners

Sharron Docherty is an associate professor and director of the pediatric acute/chronic care specialty at the Duke University School of Nursing. She practices as a pediatric nurse practitioner at Duke Children's Hospital. She has 25 years experience working with children with cancer and other life-limiting illnesses. Dr. Docherty's program of research is focused upon examining how life-sustaining treatment impacts the short- and long-term functioning of acute and chronically ill children and their families. She utilizes longitudinal and mixed method research methodologies to investigate the phenomena in this area and has been funded by NIH as a principal and co-investigator.

Dr. Nancy L. Fisher, MD, MPH Chief Medical Officer Washington State Health Care Authority

Nancy Fisher is the Medical Director for the Health Care Authority. She has board certification in pediatrics and clinical genetics. At the University of Washington, she is a Clinical Associate Professor of Pediatrics and active with the Institute for Public Health Genetics of the School of Public Health. James H. Glauber is Senior Medical Director of Neighborhood Health Plan, a Medicaid-predominant HMO located in Boston, MA. He has served in that position since 2002. He also practices pediatrics at Harvard Vanguard Medical Associates, both as a primary care physician and directing the Central Pediatric Asthma Program. Dr. Glauber completed a Pediatric Health Services Research fellowship at Harvard Medical School in 2001 and received an MPH in the Clinical Effectiveness Program at the Harvard School of Public Health in 2001. Prior to his fellowship training Dr. Glauber was a primary care pediatrician in the Permanente Medical Group from 1993-1999 in Hayward, CA. While her leadership spans all pediatric conditions, she has been most successful in implementing pediatric shared medical visits for children with asthma and their caregivers and obesity. Because of her pioneering efforts, she and the Parkland community oriented primary care clinics (COPCs) were the recipient of an Exxon Mobil grant further defining and expanding this model. That program targeted six elementary schools in the Dallas Independent School District, in especially high-risk populations of children from southeast Dallas beginning in 2005.

James Quirk, MD, PhD, joined the department of obstetrics, gynecology, and reproductive medicine as professor and chairman in 1998. Dr. Zima led the first statewide quality of care study for children in publicly-funded outpatient mental health programs, and was awarded American Academy of Child and Adolescent Psychiatry's top scientific honor for the most significant research paper. She is principal investigator on a National Institute of Mental Health funded study examining the quality of ADHD care for children in primary and specialty mental health care within a large Medicaid managed care program. Her earlier research is dedicated to improving access to mental health care for high risk children.
