Consensus Standards Approval Committee (CSAC) Voting Results and Decisions for Fall 2020 Measures

The Consensus Standards Approval Committee (CSAC) convened for a two-day web meeting on June 29-30, 2021, to review candidate measures in the fall 2020 cycle. The tables below illustrate voting results for the All-Cause Admissions and Readmissions, Behavioral Health and Substance Use, Cardiovascular, Cost and Efficiency, Geriatrics and Palliative Care, Neurology, Patient Experience and Function, Patient Safety, Perinatal and Women's Health, Prevention and Population Health, Primary Care and Chronic Illness, Renal, and Surgery measures submitted in this review cycle. The CSAC decisions regarding measure endorsement are final, without ratification by the National Quality Forum (NQF) Board of Directors. The NQF 30-day Appeals period for endorsed measures is open from July 7, 2021, to August 5, 2021.
