#### **Prevention and Population Health (PPH) Standing Committee Recommendations**

- 1 measure reviewed for fall 2020
  - 1 measure reviewed by the Scientific Methods Panel
- I measure recommended for endorsement
  - 3592e Global Malnutrition Composite Score (Academy of Nutrition and Dietetics/Avalere Health LLC), (new)



#### **Overarching Issues for PPH**

- Disparities Data
  - The Standing Committee requested consistent reporting of disparities data in all measure submission to discern meaningful performance differences within and between populations. Members recommended including this request as a measure evaluation requirement. They noted that reporting performance rates without disparities data does not clearly identify actionable performance gaps, has the potential mask gaps with overall "topped out" performance when care is needed for select populations, and is seen as a lost opportunity to reduce inequities in healthcare access, quality, and delivery.

  - 15 supportive comments for the measure under review (NQF #3592e)
  - 2 comments seeking clarification for the measure under review
  - 1 comment from developer for responding to clarification comments

#### **Cardiovascular (CV) Standing Committee Recommendations**

- Two measures reviewed for fall 2020
  - Both measures were reviewed by the Scientific Methods Panel (SMP passed both measures on Scientific Acceptability criterion)
- Two measures recommended for endorsement
  - NQF #0229 Hospital 30-Day, All-Cause, Risk-Standardized Mortality Rate (RSMR) Following Heart Failure (HF) Hospitalization (Yale CORE/CMS) (maintenance)
  - NQF #0230 Hospital 30-Day, All-Cause, Risk-Standardized Mortality Rate (RSMR) Following Acute Myocardial Infarction (AMI) Hospitalization (Yale CORE/CMS) (maintenance)



# **CV: Public and Member Comment and Member Expressions of Support**

- Five comments received
  - All five comments were not supportive of the measures under review (three comments for NQF #0229 and two comments for NQF #0230)
    - » Measure reliability, particularly at lower case counts, does not meet reliability standards
    - » Decision to not include social risk adjustment
    - » Inadequate exclusions
    - » Inadequate number of outliers for performance
- No NQF member or non-member expressions of support received

  - 3 comments were supportive of the measure under review but expressed a desire for better Mediolateral vs. Midline episiotomy coding in the future for #0470
  - 1 comment submitted by the developer clarified their methods for testing the measure #0470
