

# **CSAC Endorsement**

## Consensus Standards Approval Committee Voting Results and Decisions for Fall 2021 Measures

The Consensus Standards Approval Committee (CSAC) convened for a web meeting on July 26, 2022, to review candidate measures for the fall 2021 cycle. The tables below illustrate voting results for the Geriatric and Palliative Care, Patient Safety, Primary Care and Chronic Illness, and Surgery measures submitted this review cycle. During the July 26 meeting, quorum was lost for six of the 13 measures due to a combination of member absences and conflict of recusals. As a result, CSAC members voted offline between July 26 and August 1 to reach voting quorum.

In addition, for the fall 2021 cycle, CSAC endorsed six of the 13 measures via a <u>consent calendar</u>. Measures on the consent calendar are approved for endorsement via a process of no objection by the CSAC (i.e., CSAC consent calendar endorsement decisions are unanimous). Only measures that received 80 percent or greater passing votes for overall suitability by the Standing Committees were included on the consent calendar. All remaining measure were voted on separately by the CSAC.

The CSAC measure endorsement decisions are final, without ratification by the National Quality Forum (NQF) Board of Directors. The NQF 30-day Appeals period for endorsed measures is open from August 4, 2022, to September 2, 2022.
