## Appeals Board Voting Results for Appeal of Measure NQF #0500 Severe Sepsis and Septic Shock: Management Bundle

The Appeals Board convened for a web meeting on April 29<sup>th</sup>, 2022, to adjudicate the appeal of the December 1, 2021, Consensus Standards Approval Committee (CSAC) maintenance endorsement decision for NQF #0500 *Severe Sepsis and Septic Shock: Management Bundle*. The tables below provide the results of the Appeals Board votes. The Appeals Board decisions regarding adjudication of the appeal are final.
