Peter Crooks, MD, is an Associate Medical Director of the Southern California Permanente Medical Group and Senior Medical Consultant to its Renal Business Group. Jeffrey Berns, MD, is professor of medicine and pediatrics at the University of Pennsylvania School of Medicine and associate chief of University of Pennsylvania's renal-electrolyte and hypertension division. He is also President-Elect of the National Kidney Foundation. Dr. Berns' clinical and research interests are in the areas of chronic kidney disease, renal pharmacology, and critical care nephrology. He is the National Kidney Foundation's Kidney Disease Outcomes Quality Initiative's vice-chair for clinical practice guidelines and commentaries, a member of the Kidney Disease Improving Global Outcomes anemia workgroup, and a member of the American Board of Internal Medicine nephrology subspecialty board. Dr. Berns went to medical school and completed residency training in internal medicine at Case Western Reserve University School of Medicine and his fellowship in nephrology at Yale University.

Andrew Narva, MD, is the director of the National Kidney Disease Education Program at the National Institutes of Health (NIH). Before joining NIH, Dr. Narva served as the chief clinical consultant for nephrology for the Indian Health Service, a public health service agency that provides healthcare to over one million American Indians and Alaska Natives. He has served as a member of the Medical Review Board of ESRD Network 15 and as chair of the Minority Outreach Committee of the National Kidney Foundation. He serves on the National Kidney Foundation Kidney Disease Outcomes Quality Initiative work group on chronic diabetes and is a member of the Eighth Report of the Joint National Committee on Prevention, Detection, Evaluation, and Treatment of High Blood Pressure Expert Panel. In 2002, Dr. Narva was recognized by the Indian Health Service National Council of Clinical Directors as Physician Leader of the Year and by the U.S. Public Health Service as the Clinical Physician of the Year. In 2003, he received the United States Public Health Service Distinguished Service Medal, the highest recognition awarded to commissioned officers. Dr. Narva is a graduate of Harvard Medical School and is board certified in internal medicine and nephrology.
