## NOTICE OF INTENT TO SUMBIT STANDARDS National Voluntary Consensus Standards for Ambulatory Care: Additional Outpatient Measures 2010

NQF is initiating a consensus development project seeking endorsement of measures for outpatient care addressing emergency department and/or urgent care and ambulatory surgery.

### NOTICE TO MEASURE STEWARDS

If, after reviewing this Notice of Intent, your organization believes it has one or more measures that address the scope and objectives of this project as described below and would like NQF to evaluate them for possible endorsement, please submit a <u>notice of intent to</u> <u>submit candidate standards</u> by **Monday**, **January 4**, **2010**. Instructions for submitting this information are given at the end of this document.

#### BACKGROUND

NQF has endorsed a wide variety of ambulatory care measures for assessment of the quality of care provided in outpatient facilities such as hospital outpatient departments (HOPD), emergency departments, urgent care facilities, ambulatory surgery centers, community health centers as well as clinician offices. As more NQF-endorsed measures are implemented, the demand for measures to fill important gaps is growing. The implementation and reporting of quality measures for hospital outpatient services builds on previous efforts in the inpatient area, having the same purpose. Endorsement of measures is intended to encourage hospitals and clinicians to improve their quality of care and to empower consumers with quality information to make informed decisions about their health care.

Ambulatory medical care is the predominant method of providing health care services in the United States and occurs in a wide range of settings. The largest proportion of ambulatory care services occurs in physician offices. Moreover, approximately 11 percent of all ambulatory medical care visits in the United States occur in the ED.<sup>1</sup> From 1996 through 2006, the number of ED visits increased from 90.3 million to 119.2 million visits annually, a 32% increase.<sup>11</sup> Yet the number of hospital EDs in the United States decreased by about 12.4 percent during the same period. Demand and capacity issues have contributed to increased patient wait-time and decreased physician productivity, and they place patients at risk for poor outcomes.

From the Medicare perspective, 17% of ED visits are covered by this payment source. Since 2008, CMS has adopted outpatient measures specifically addressing ED and ambulatory surgical center quality of care. CMS projects that total payments for services furnished to people with Medicare in HOPDs during CY 2010 under the Outpatient Prospective Payment System (OPPS) will be \$32.2 billion, while total projected CY 2010 payments under the ASC payment system will be approximately \$3.4 billion. To date, NQF has endorsed measures for these healthcare facilities, but few measures have been endorsed beyond process measures.

All notices of intent to submit measures must be submitted by 6:00 p.m. ET on Monday, January 4, 2010.

### SCOPE OF ACTIVITIES

The National Quality Forum seeks to identify and endorse additional measures of outpatient care addressing emergency department and/or urgent care and ambulatory surgery for public reporting and quality improvement.

### THE NQF PROCESS

The candidate measures will be considered for NQF endorsement as voluntary consensus standards. Agreement around the recommendations will be developed through NQF's formal Consensus Development Process (CDP). This project will involve the active participation of representatives from across the spectrum of healthcare stakeholders and will be guided by a Steering Committee with assistance from multiple, condition-specific Technical Advisory Panels (TAPS).

Any organization or individual may submit measures for consideration. To be evaluated, candidate consensus standards must meet the following general criteria:

- Be fully developed for use (e.g., research and testing have been completed);
- Be intended for use in both public reporting and quality improvement;
- Be open source or in the public domain<sup>1</sup>; and
- Have an identified measure steward<sup>2</sup>.

Measure stewards must also have a fully executed Measure Steward Agreement with NQF. Information on submitting measures to NQF can be found on the NQF website.

#### FUNDING

#### MEASURE STEWARDS: NOTICE OF INTENT TO SUBMIT CANDIDATE STANDARDS

Measures stewards anticipating submission of candidate measures to NQF for this project should submit a notice of intent. A Microsoft Word document containing a list of measures should be sent to <u>ambulatorycare@qualityforum.org</u>, subject line "Ambulatory Care" no later than **Monday**, **January 4**, **2010 at 6 p.m. ET**. This list should include:

NQF requires any non-government organization submitting a measure for endorsement to execute a Measure Steward Agreement that addresses intellectual property protection and disclosure of the measure's proprietary components, including but not limited to specifications, risk adjustment methodologies, data collection instrument, data collection or analysis software, and database access. <sup>&</sup>lt;sup>2</sup> NQF requires any measure considered for endorsement to have an identified responsible entity and process to maintain and update the measure on a schedule commensurate with clinical innovation, but at least every 3 years. Measure stewards must execute a <u>Measure Steward Agreement</u> with NQF.
