Andrew Ryan, PhD

Associate Professor, Department of Health Management and Policy, University of Michigan

Prior to coming to Michigan, Dr. Ryan was an Associate Professor of Public Health in the Division of Outcomes and Effectiveness Research at Weill Cornell Medical College. Dr. Ryan has a PhD in Social Policy with a concentration in Health Policy from the Heller School of Social Policy and Management, Brandeis University. Dr. Ryan's research focuses on pay-for-performance and public quality reporting, disparities, measurement of quality and value, and health care policy analysis. He won the 2009 AcademyHealth Dissertation Award for his dissertation, "The Design of Value Based Purchasing in Medicare: Theory and Empirical Evidence" and the John M. Eisenberg Article-of-the-Year in Health Services Research for "Has Pay-for-Performance Decreased Access for Minority Patients?".

Ariel Linden, DrPH

Dr. Linden currently holds a research scientist appointment in the division of general medicine at the University of Michigan, as well as an adjunct associate professorship in the department of Health Management and Policy. Prior, he held a joint faculty appointment at Oregon Health and Science University's School of Medicine and School of Nursing. Dr. Linden began his healthcare career as a clinical scientist in the areas of cardiovascular and pulmonary physiology. He completed his doctorate at UCLA in health services research in 1997, extending his expertise in clinical research to measurement and evaluation strategies of large scale and population-based interventions. Dr. Linden has published over 80 peer-reviewed papers, book chapters, letters to the editor, and scientific abstracts. In 2006, Dr. Linden won the DMAA's prestigious award for "Outstanding Journal Article." In 2008, he was named "Leader in Disease Management" by Managed Healthcare Executive. He further contributes to academic advancement as an Associate Editor of the Journal of Evaluation in Clinical Practice and serves on the editorial board of seven other medical journals.

Brahmajee Nallamothu, MD, MPH

Associate Professor, Department of Internal Medicine in the Division of Cardiovascular Medicine, University of Michigan

Dr. Nallamothu received his medical degree from Wayne State University in Detroit and then completed his internal medicine, cardiovascular medicine, and interventional cardiology training at the University of Michigan. He has also completed an Agency for Healthcare Research and

Quality Fellowship, during which he completed a master of public health degree in healthcare management and policy. Dr. Nallamothu has been on the faculty at the University of Michigan since 2004. His research focus has been on improving the delivery and quality of specialized cardiovascular procedures through population-based approaches. His contributions include examining: (1) the quality and appropriateness of percutaneous coronary interventions, (2) hospitalized patients with cardiac arrests, and (3) use of cardiac imaging. His work has been funded by the National Institutes of Health and the Agency for Healthcare Research and Quality.

Rachel Werner, MD, PhD

Associate Professor of Medicine, Division of General Internal Medicine, University of Pennsylvania
Core Investigator with the VA HSR&D Center, Health Equity Research and Promotion

Dr. Werner received her medical degree from the University of Pennsylvania School of Medicine, where she also did her residency in Internal Medicine. While completing a clinical fellowship in general internal medicine, she also received a Ph.D. in health economics from the Wharton School at the University of Pennsylvania. Dr. Werner's research seeks to understand the effect of health care policies and delivery systems on quality of care. In particular, she has examined the role of quality improvement incentives on provider behavior, the organization of health care, racial disparities, and overall health care quality. Her work has empirically investigated numerous unintended consequences to quality improvement incentives and was among the first to recognize that public reporting of quality information may worsen racial disparities. She has received numerous awards including the Dissertation Award and the Alice Hersch New Investigator Award from AcademyHealth and the Presidential Early Career Award for Scientists and Engineers. Her research has been published in high-impact peer-reviewed journals, including JAMA, Health Services Research, and Health Affairs. In addition to her research, Dr. Werner is a practicing primary care internist at the Philadelphia VA Medical Center and regularly attends the hospital's internal medicine service. She supervises health care provided by Hospital of the University of Pennsylvania internal medicine residents and medical students..
