Peter Briss, MD, MPH

Medical Director, CDC, National Center for Chronic Disease Prevention and Health Promotion Chamblee, Georgia

Dr. Peter Briss has been with CDC and the US Public Health Service for 23 years performing crossdisciplinary research and service addressing topics ranging from health care to community prevention including lead poisoning, vaccine preventable disease, tobacco, cancer, heart disease, and oral health. For the past 10 years, he has worked closely with the Arkansas Medicaid Pharmacy Section developing strategies for the utilization of antipsychotic and stimulant medications in children and adolescents. Since moving to Arkansas Medicaid fulltime in January 2013, as Senior Psychiatrist, he increased these efforts and review outcomes regularly. To date, the organization has decreased the use of antipsychotics 93% in non-foster children and 86% in foster children. Polypharmacy is another focus and I have developed and implemented interventions to address this issue.

Bonnie Zima, MD, MPH

Professor in Residence, Child and Adolescent Psychiatry, UCLA Semel Institute for Neuorscience and Human Behavior Los Angeles, California

Bonnie T. Zima, MD, MPH is Associate Director of the UCLA Center for Health Services and Society and Professor-in-Residence (Child and Adolescent Psychiatry) in the UCLA Department of Psychiatry and Behavioral Sciences at the David Geffen School of Medicine. Her research focuses on the unmet need for mental health services among high risk child populations (i.e., homeless, foster care, juvenile justice) and the quality of mental health care for children enrolled in Medicaid-funded outpatient programs. Dr. Zima led the first statewide study on quality of publicly-funded outpatient child mental health care which developed and reported adherence to 121 quality indicators. Guided by this research, Dr. Zima led a five-year NIMH funded study that examined the quality of care and 18-month clinical outcomes among 546 children receiving care for ADHD in primary care and specialty mental health clinics within one of the nation's largest managed care Medicaid health plans. Currently, Dr. Zima is PI on a mobile health pilot study to optimize stimulant medication treatment for children with ADHD served in publicly-funded mental health programs and a five-year study examining the implementation of an integrated care model in two large, publicly funded federally qualified health care centers in Chicago. Her research has received all three national research awards from the American Academy of Child and Adolescent Psychiatry (AACAP).

Leslie Zun, MD, MBA

Chair, Department of Emergency Medicine, Mount Sinai Hospital Wilmette, Illinois

Leslie S. Zun, M.D., M.B.A. is the Chairman of the Department of Emergency Medicine at Mount Sinai Hospital in Chicago, Illinois and Chairman & Professor, Department of Emergency Medicine at the Rosalind Franklin University of Medicine and Science/Chicago Medical School in North Chicago, Illinois. His background includes a medical degree (M.D.) from Rush Medical College and a business degree (M.B.A.) from Northwestern University's JL Kellogg School of Management.
