#### Behavioral Health and Substance Use

- The Behavioral Health and Substance Use project aims to endorse measures of accountability for improving the delivery of behavioral health and substance use services and achieving better health outcomes for the U.S. population.
- NQF's Behavioral Health and Substance Use portfolio includes 54 measures that address the following topic areas:
  - » Tobacco
  - » Alcohol and substance use
  - » Depression
  - » Medication use
  - » Care Coordination
  - » Physical health

#### Behavioral Health and Substance Use

- Measures Under Review:
  - Nine measures under consideration
  - Seven maintenance measures and two new measures
- Topic areas:
  - Suicide risk assessments
  - Medication adherence and management
  - Diabetes and cardiovascular screening and monitoring for individuals with schizophrenia and bipolar disorder
  - Concurrent use of opioids and benzodiazepines
  - Use of pharmacotherapy for opioid use disorder
- No measures were submitted to the Scientific Methods Panel

## Overarching Issues

- Medication adherence
  - Committee would like to see consistent language across behavioral health and substance use for all medication adherence measures.
- NQF measure evaluation criteria changes
  - NQF received several communications from measure developers expressing concern that the change in the subcriterion allowed for a very short window of time to respond to the new testing requirement.
- Overall performance improvement rates
  - Updated performance data showed little overall performance improvement despite continued variation indicating a gap in care in maintenance measures.

## Public and NQF Member Comments Received

- 57 comments were received from 17 organizations (including nine member organizations)
- Four major themes were identified in the comments:
  - General Comments
  - Feasibility/Data Collection
  - Expansion of Measured Population
  - Unintended Consequences
- The Committee did not vote on any measures on the post-comment web meeting
