The CSAC will review recommendations from the *Care Coordination Phase 3* project at its March 18-19th web meeting. This serves as an addendum to the previous memo and contains the updated voting results as of the ending of the NQF member voting period on July 7th.

NQF MEMBER VOTING RESULTS

All of the recommended measures were approved, with 57% approval or higher by the councils. Representatives of 9 member organizations voted; no votes were received from the Consumer, Public/Community Health Agency, and Purchaser Councils. Results for each measure are provided below.
