# R. Sean Morrison, MD

Dr. Morrison has served on the MAP Hospital Workgroup since 2011. He has extensive knowledge of quality measurement and the nine different federal hospital and setting-specific quality programs. He is a demonstrated leader in the field of palliative medicine, both providing direct care to patients and spearheading countless national research initiatives to expand the evidence-base and ensure that findings are rapidly translated into clinical practice. This research includes pain and symptom management in high-risk and medically underserved populations, decision making at the end of life, and quality measures in palliative care. Most recently, Dr. Morrison's research has focused on improving the management of pain in older adults and on developing and evaluating models of palliative care delivery in hospitals and the community. Outside of MAP, he has chaired numerous task forces and committees, both nationally and internationally, and served as the President of the American Academy of Hospice and Palliative Medicine. Dr. Morrison's CV demonstrates his vast experience directing and conducting research and reporting findings back to a number of federal entities including NIH and HHS.

## Deborah Waldrop, PhD, LMSW, ACSW

Deborah Waldrop, LMSW, PhD is a Professor and the Associate Dean for Faculty Development at the University at Buffalo School of Social Work (UBSSW). Deborah joined the UBSSW faculty after spending 20 years as a social worker in a variety of healthcare settings including hospice. Drawing from the experiences of older adults and their families Dr. Waldrop conducts research about the needs and concerns that emerge at life's end, means for improving advance care planning, and caregivers' adaptation in bereavement. Deborah participated as a member of the American Academy of Hospice and Palliative Medicine's Measuring what Matters initiative.

Dr. Margie Atkinson is the Director of Pastoral Care, Ethics and Palliative Care programs for Morton Plant Mease Healthcare, part of BayCare Health System in the Tampa Bay Area of Florida. Atkinson's expertise includes pastoral and spiritual care, and administration in multiple settings, including hospice, acute care, and children's hospital settings. Atkinson currently oversees the spiritual care and palliative care services for four acute care hospitals and one LTACH in the Tampa Bay area. She implemented a clinical pastoral education program in BayCare Health System and has been instrumental in developing palliative care in two health systems. She currently co-leads the 13-hospital system's palliative care collaborative, a group consisting of leadership from across the system.

Sree Battu, MD, is board certified in Physical Medicine and Rehabilitation, Hospice and Palliative Medicine, and Brain Injury Medicine. She is a Senior Associate Consultant at Mayo Clinic working in the Palliative Care Multidisciplinary Enterprise Group. Previously, she worked at the Cleveland Clinic and the Veterans Health Care System. While at Cleveland Clinic she served as PM&R Quality Review Officer, Enterprise Fall Prevention/Management Co-Chair, and Assistant Residency Program Director. She was responsible for developing and implementing several quality projects with multidisciplinary teams and teaching about transitions through the post-acute continuum emphasizing the need for patient safety and quality.

Amy Berman, a senior program officer with The John A. Hartford Foundation, is best known for publicly sharing her experiences living with stage 4 breast cancer. She authored pieces on value in healthcare decisions, palliative care, and implications for patients, practice, and policy. Her piece in *Health Affairs*, Living Life In My Own Way—And Dying That Way As Well, was among the most read in the history of the journal. At the John A. Hartford Foundation, Ms. Berman, a nurse, leads the Foundation's investments

in models of care that improve health of older adults including palliative care. Ms. Berman is the recipient of numerous honors for advocacy on behalf of those facing serious illness including the Presidential Citation from AAHPM.

## Cleanne Cass, DO, FAAHPM, FAAFP

Director of Community Care and Education, Hospice of Dayton Dayton, Ohio

Cleanne Cass, DO, FAAHPM, FAAFP is the Director of Community Care and Education, Hospice of Dayton, heading in-home patient services and education for medical students, residents, and fellows in Hospice and Palliative Medicine. Dr. Cass is an appointed member of the Ohio Governor's Cabinet Opioid Action team developing guidelines for safe opioid prescribing. She is also a member of the state task force working toward implementation of MOLST (medical orders for life sustaining treatment). She represented the AOA on the NQF Advisory Panel which developed *A National Framework and Preferred Practices for Palliative and Hospice Care Quality* published December 2006.

#### Marian Grant, DNP, CRNP

Senior Regulatory Advisor, Coalition to Transform Advanced Care (C-TAC) Washington, DC

Marian Grant is Senior Regulatory Advisor for the Coalition to Transform Advanced Care and a policy consultant for the Center to Advance Palliative Care. In those roles she reviews proposed regulations, payment models, and quality measures and drafts comments on those affecting people with serious illness. She helped draft the new community-based palliative care standards and certification for the Community Health Accreditation Partner (CHAP) and is on the NQF Committee for its Serious Illness Network. Dr. Grant practices as a palliative care nurse practitioner at the University of Maryland Medical Center and speaks nationally and internationally on palliative care.

Rev. Handzo is widely regarded as a leading international authority on the practice of professional healthcare chaplaincy. He participated in the development of the Systems of Belief Inventory (SBI). He led the effort that created North American standards for the certification of chaplains, and is currently leading the development of the first set of measurable outcomes for healthcare chaplaincy. Rev. Handzo has been part of two national and one international interdisciplinary consensus conferences developing models and goals for the integration of spiritual care in healthcare and is a member of the Global Network for Spirituality and Health leadership team.

## Arif H. Kamal, MD, MBA, MHS, FACP, FAAHPM

Currently, her research focuses on communication and decision making among patients, family caregivers, and professional caregivers in the pediatric intensive care unit as well as in the palliative care setting. Her work uses qualitative and quantitative methods, and patient/stakeholder engagement and community-based participatory research methods.

## Lynn Reinke, PhD, ARNP, FAAN

Lynn Reinke's program of research focuses on improving the delivery of palliative care for patients with advanced, serious illnesses, specifically COPD, lung cancer, and multimorbidities. Ms. Reinke is testing methods of identifying unmet physical and psychosocial needs among older patients with multimorbidities and is sought out for her clinical expertise in managing patients with severe dyspnea and dyspnea crisis. In her role as a Health & Aging Policy fellow, she is working on aggregating data from care plans to allocate community resources for elderly persons whose goal is to remain independent. She is a recipient of the Hartford Geriatric Social Work Faculty Scholar Award, a national award that provided support for her research in the area of aging and end of life. Nationally, Dr. Schroepfer is president of the Association for Gerontology Education in Social Work (AGESW), an executive committee member of the Social Work and Hospice Palliative Care Network (SWHPN), and a prior member of the National Quality Forum (NQF) Palliative Care and End-of-Life Steering Committee. Dr. Schroepfer served as a reviewer for the Institute of Medicine's (IOM) 2014 report, *Dying in America: Improving Quality and Honoring Individual Preferences Near the End of Life*. She has been an invited participant to several end-of-life and healthcare think tank meetings held in Washington, DC by the National Association of Social Workers (NASW).

There, Schwimmer was on the leadership team that brought Accountable Care Organizations and the largest Patient Centered Medical Home program to New Jersey.

Ms. Schwimmer also served in State Government as Director of Legislation and Policy for the New Jersey Department of Banking and Insurance, where she represented the Department's position before the State Legislature and worked with state and federal officials on priority legislative initiatives impacting the insurance, banking, and real estate industries.
