Amy J. Berman, BSN, LHD, FAAN

Senior Program Officer, John A. Hartford Foundation New York, New York

Amy Berman is a Senior Program Officer with The John A. Hartford Foundation and is best known for publicly sharing her experiences living with stage IV breast cancer. She authored pieces on value in healthcare decisions; palliative care; and implications for patients, practice, and policy. Her piece in *Health Affairs* titled *Living Life In My Own Way—And Dying That Way As Well* was among the most read in the history of the journal. At the John A. Hartford Foundation, Ms. Berman, also a nurse, leads the foundation's investments in models of care that improve the health of older adults, including palliative care. Ms. Berman is the recipient of numerous honors for advocacy on behalf of those facing serious illness, including the Presidential Citation from the American Academy of Hospice and Palliative Medicine (AAHPM).

R. Sean Morrison, MD

Co-Director, Patty and Jay Baker National Palliative Care Center; Director, National Palliative Care Research Center; Director, Hertzberg Palliative Care Institute, Icahn School of Medicine at Mount Sinai New York, New York

Dr. R. Sean Morrison has served on the Measure Applications Partnership (MAP) Hospital Workgroup since 2011. He has extensive knowledge of quality measurement and the nine different federal hospital and setting-specific quality programs. He is a demonstrated leader in the field of palliative medicine, both providing direct care to patients and spearheading countless national research initiatives to expand the evidence base and ensure that findings are rapidly translated into clinical practice. This research includes pain and symptom management in high-risk and medically underserved populations, decision making at the end of life, and quality measures in palliative care. Most recently, Dr. Morrison's research has focused on improving the management of pain in older adults and on developing and evaluating models of palliative care delivery in hospitals and the community. Outside of MAP, he has chaired numerous task forces and committees, both nationally and internationally, and served as the President of AAHPM. Dr. Morrison's CV demonstrates his vast experience directing and conducting research and reporting findings back to a number of federal entities, including the National Institutes of Health (NIH) and the United States (U.S.) Department of Health and Human Services (HHS).

President and CEO, Hope HealthCare Services Fort Myers, Florida Dr. Samira Beckwith has more than 30 years of experience in hospice and healthcare. As President and CEO of Hope HealthCare Services for over 25 years, Dr. Beckwith has created an innovative national model of healthcare for the future by bridging hospice with other long-term care programs. She also launched a successful PACE (i.e., Program of All-Inclusive Care for the Elderly) program and recently expanded the Hope Kids Care program to meet growing community needs. Dr. Beckwith has clinical, administrative, and public policy expertise, as well as extensive federal- and private-payer knowledge. She is a frequent participant in national and state health policy forums and has provided expert testimony before government bodies, including the U.S. House Judiciary Committee and U.S. Senate Aging Committee.

Cleanne Cass, DO, FAAHPM, FAAFP

Director of Community Care and Education, Hospice of Dayton Dayton, Ohio

Dr. Cleanne Cass is the Director of Community Care and Education at the Hospice of Dayton, heading inhome patient services and education for medical students, residents, and fellows in hospice and palliative medicine. Dr. Cass is an appointed member of the Ohio Governor's Cabinet Opioid Action Team, developing guidelines for safe opioid prescribing. She is also a member of the state task force working toward implementation of MOLST (i.e., medical orders for life-sustaining treatment). She represented the American Optometric Association on the National Quality Forum's (NQF) Advisory Panel, which developed *A National Framework and Preferred Practices for Palliative and Hospice Care Quality* published in December 2006.

Dr. William Curry is a professor in the departments of family and community medicine and public health sciences at the Penn State College of Medicine in Hershey, Pennsylvania. He is a practicing family physician, a member of the American Academy of Family Physicians (AAFP), and currently actively involved in institutional and departmental quality work and primary care research. In his quality work at Penn State College of Medicine, Dr. Curry directs care management programs, many of which are driven by NQF specifications.

After graduating from Rice University in Houston, Texas with a degree in chemical engineering and mathematics, Dr. William Glomb completed his medical training at the University of Texas Medical Branch in Galveston. He subsequently completed his pediatric internship/residency at Scott & White – Texas A&M University Medical School and his fellowships in the Division of Neonatology and Pediatric Pulmonology at Children's Hospital Los Angeles and the University of Southern California Keck College of Medicine. He is a Fellow of the American College of Chest Physicians, where he has held multiple leadership, faculty, and committee positions, and the American Academy of Pediatrics. From 2008–2013, he was the Chief Medical Director for the Texas Health and Services Commission guiding the State's Medicaid; Children's Health Insurance Program (CHIP); and other programs, including overseeing new innovative projects for predominantly children. Since 2013, Dr. Glomb has served as the Senior Medical Director at Superior HealthPlan/Centene Corporation, where he now provides medical direction for the Quality and Qualifying Individual (QI) programs, as well as for the Clinical Engagement Team, overseeing value-based contracting and alternative payment models and helping network providers in achieving quality process and outcomes measures success.

Dr. Marian Grant is the Senior Regulatory Advisor for the Coalition to Transform Advanced Care and a policy consultant for the Center to Advance Palliative Care. In those roles, she reviews proposed regulations, payment models, quality measures, and drafts comments on those affecting people with serious illness. She helped draft the new community-based palliative care standards and certification for the Community Health Accreditation Partner (CHAP) and serves on NQF's Committee for its Serious Illness Network. Dr. Grant practices as a palliative care nurse practitioner at the University of Maryland Medical Center and speaks nationally and internationally on palliative care.

Dr. Tracy Schroepfer is a professor at the University of Wisconsin-Madison School of Social Work and is affiliated with the University's Institute on Aging, Comprehensive Cancer Center, and Center on Patient Partnerships. She is a recipient of the Hartford Geriatric Social Work Faculty Scholar Award, a national award that provided support for her research in the area of aging and end of life. Nationally, Dr. Schroepfer is the Co-Director of the Association for Gerontology Education in Social Work (AGESW) Pre-Dissertation Fellows Program and is serving on the National Coalition for Hospice and Palliative Care. She is also a prior member of NQF's Palliative Care and End-of-Life Steering Committee. Dr. Schroepfer served as a reviewer for the Institute of Medicine's (IOM) 2014 report titled Dying in America: Improving Quality and Honoring Individual Preferences Near the End of Life. She has been an invited participant to several end-of-life and healthcare think tank meetings held in Washington, DC by the National Association of Social Workers (NASW).

Linda Schwimmer is the President and CEO of the New Jersey Health Care Quality Institute, a nonprofit focused on improving the quality and affordability of healthcare in New Jersey. Ms. Schwimmer is also a member of the Board of The Leapfrog Group, a national hospital safety advocacy group that issues the Hospital Safety Grade. Ms. Schwimmer serves on the Board of the Network for Regional Healthcare Improvement, is Vice Chair for NQF's Consensus Standards Approval Committee (CSAC), and also serves on NQF's Palliative and End-of-Life Care Standing Committee. In addition, Ms. Schwimmer served as a co-chair on Governor Phil Murphy's healthcare transition team. Prior to joining the Quality Institute, Ms. Schwimmer was the Director of Strategic Relations & External Affairs at Horizon Healthcare Innovations, a subsidiary of Horizon Blue Cross Blue Shield of New Jersey.
