Framework for Healthcare System Readiness

Scope:

- Focus on the quality measurement of healthcare delivery by the healthcare system prior to, during, and after emergencies and disasters.

Purpose:

- To serve as a conceptual framework and guidance for future development of readiness measures
- To facilitate systematic prioritization of measures and/or measurement areas

Meeting Objective

- To finalize preliminary domains, subdomains, and measure concepts of the measurement framework prior to public comment

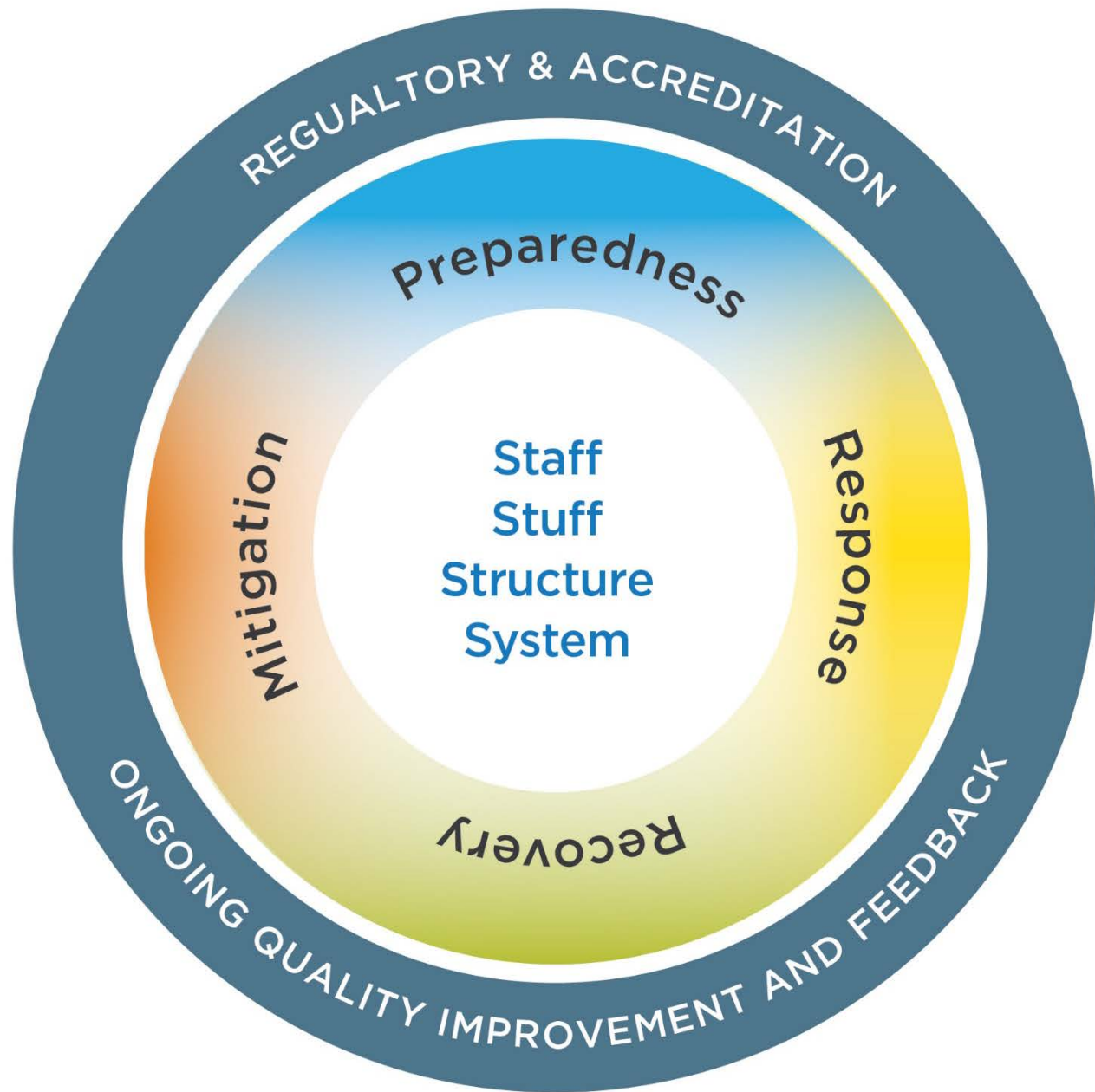
