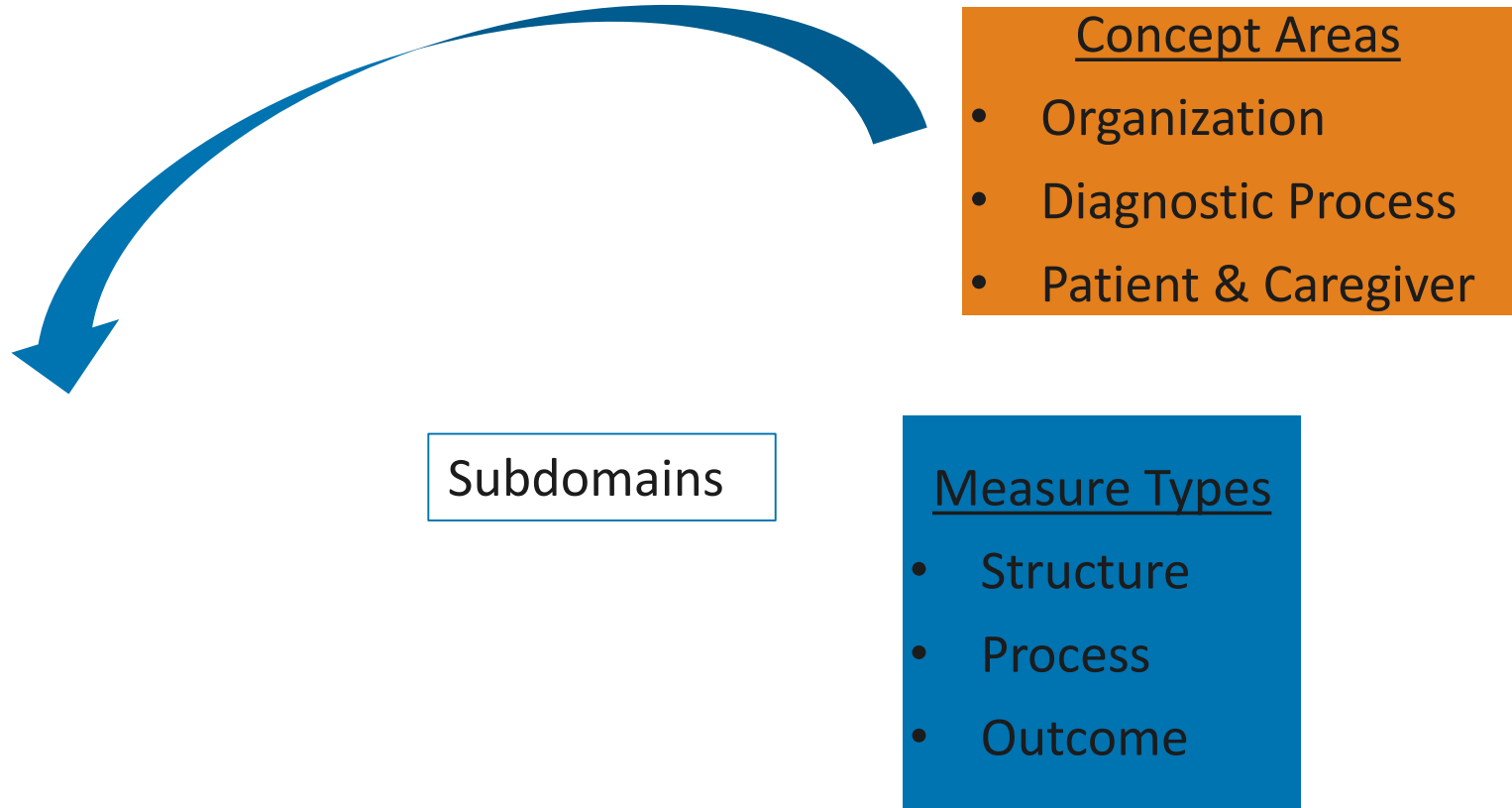

Selection of measures/measure concepts

- A subset of the measures or measure concepts from each subdomain will be selected for full rating against the prioritization criteria
- Questions to consider:
 - *Have the correct concepts been selected from each subdomain?*
 - *Can any of the concepts be further specified or described?*
 - *Should any of the concepts be re-categorized?*
 - *Are the subdomains themselves appropriate, or do they need to be modified/amended?*

Assessment of Gaps

- Committee members will assess whether there are gaps in each subdomain, and identify concepts to fill those gaps, if possible
- Questions to consider:
 - *Are there any gaps that have not yet been identified?*
 - *Are there potential measure concepts that would address those gaps?*
 - *Could/should any concepts be broadened or generalized?*

Rating Concepts

- Committee members will rate the measures that emerge from the previous discussions and rate them against the prioritization criteria:
 - *Importance*
 - *Feasibility*
 - *Contribution to cost savings*

Overarching and Cross-cutting Issues
