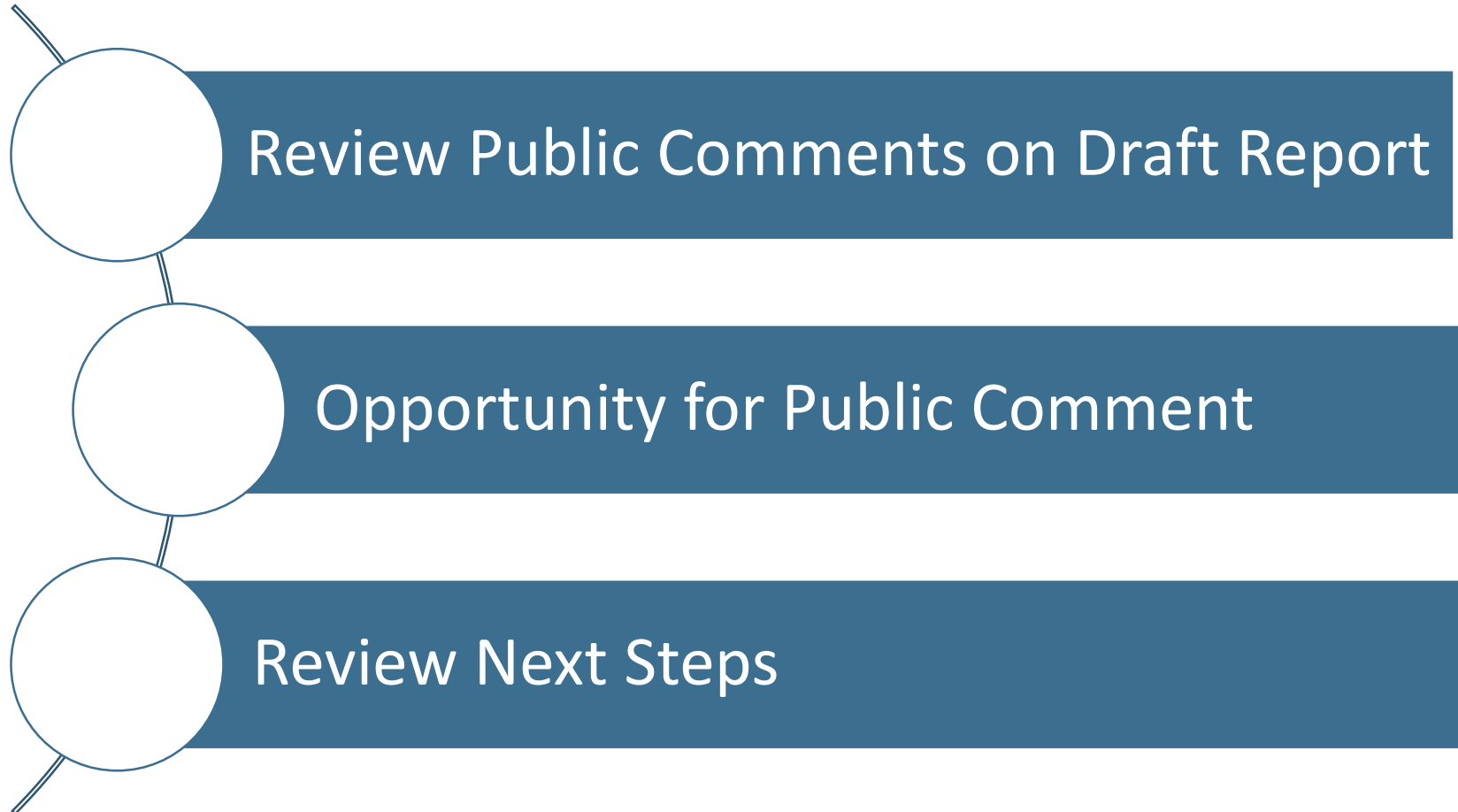

Charge of the MAC Scorecard Committee

The Scorecard Committee is charged with exploring the existing Child and Adult Core Set measures and recommending measures for addition to, and removal from, the Scorecard that can be used to support the MAC Scorecard's state health system performance pillar.

- ▣ *Potential measures for addition to the Scorecard will focus on addressing the use and usefulness of measure implementation and reporting.*

Standing Committee Measure Review Process

- Staff compiled Adult and Child Core Set measures into an Excel spreadsheet, providing measure specification information to Committee members.
- Guided by MAP's Measure Selection Criteria (MSC), a defined decision algorithm, and state data on the measures reported in FFY 2017, Committee members reviewed measures in the Child and Adult Core Sets.
- Committee members submitted measure recommendations from the Child and Adult Core Sets to be discussed during the January in-person meeting.
- Committee members voted on measures. Measures required support of >60% of voting members to move forward

Scorecard Committee Strategic Recommendations

- Encourage CMCS to structure Scorecard's evolution in two phases: Refinement and Feedback
 - ▣ *Refinement – Refine the measure set to optimize usage*
 - ▣ *Feedback – solicit continuous state feedback and performance data to prioritize use of measures*

Review and Discuss Public Comments

Themes from Public Comments

25 comments from 10 organizations

Measure Specific Comments

- All measures recommended for addition to and/or removal from the MAC Scorecard received support.
- NQF received comments in support of and against the recommendation to retain measure 2940 (Use of Opioids at High Dosage in Persons Without Cancer) on the Scorecard.

Themes from Public Comments

Strategic Comments/General Comments

- Encouraged CMCS to reevaluate the Measure Selection Criteria/measures considered for addition to future iterations of the Scorecard (e.g., expanding potential measure additions beyond Medicaid and CHIP Core Set measures reported by 25 or more states.)
- Encouraged CMCS to “finalize and communicate” the near- and long-term accountability plans
- Support for continued focus on:
 - ▣ *Alignment and parsimony*
 - ▣ *Emphasis on fewer, more cross-cutting high-impact measures*
 - ▣ *Emphasis of measures telling of quality of care, outcomes, and experiences*
 - ▣ *Measures addressing life-span of Medicaid and CHIP beneficiaries*

Themes from Public Comments

Strategic Comments/General Comments

Gaps to fill in future iterations

- Experience of care measures
- Long-term services and supports
- Long-term care utilization measures
- Women of reproductive age (i.e., measures addressing wellness, primary care, and prevention)
- Maternal, perinatal, and newborn healthcare
- Mental health and substance use outcome measures
- Disparities
