### **Measure Review Process**

- Staff compile Adult and Child Core Set measures into an Excel spreadsheet, providing measure specification information
- Committee members submit measure recommendations from the universe of measures included in the Excel spreadsheet
- Staff complete a preliminary analysis algorithm on each recommended measure
- Only measures recommended for review by Committee members become measures for consideration during the inperson meeting
- Measure specifications and preliminary analysis results will be shared during the in-person meeting via an electronic discussion guide

### **Tools Used to Guide Measure Review**

### **MAP's Measure Selection Criteria (MSC)**

- NQF-endorsed measures are required for program measure sets, unless no relevant endorsed measures are available to achieve a critical program objective
- Program measure set actively promotes key healthcare improvement priorities, such as those highlighted in CMS' "Meaningful Measures" Framework
- Program measure set is responsive to specific program goals and requirements
- Program measure set includes an appropriate mix of measure types
- Program measure set enables measurement of person- and family-centered care and services
- Program measure set includes considerations for healthcare disparities and cultural competency
- Program measure set promotes parsimony and alignment

### MAP Preliminary Analysis Algorithm

- 1) The measure addresses a critical quality objective not adequately addressed by the measures in the program set.
- 2) The measure is evidence-based and is either strongly linked to outcomes or an outcome measure.
- 3) The measure addresses a quality challenge.
- 4) The measure contributes to efficient use of measurement resources and/or supports alignment of measurement across programs.
- 5) The measure can be feasibly reported.
- 6) The measure is applicable to and appropriately specified for the program's intended care setting(s), level(s) of analysis, and population(s).
- 7) If a measure is in current use, no negative unintended issues to the patient have been identified.
- 8) If a measure is in current use, no implementation challenges outweighing the benefit of the measure have been identified.

### **Timeline for Next Scorecard Releases**

- Jun. Oct.2018: CMCS identified candidate measures for the next Scorecard releases
- <u>Aug. 2018</u>: CMCS began meeting with a group of state officials on a monthly basis to receive feedback on candidate measures
- <u>Nov. 2018-Jan. 2019</u>: CMCS plans to finalize new measures for next Scorecard releases, reflecting state, stakeholder, and Administrator feedback
- <u>Apr. -Jun. 2019</u>: State Medicaid agency reviews, final edits, clearances, and second release of Scorecard (Focus of today's update)
- Jun. Nov. 2019: State Medicaid agency reviews, final edits, clearances, and third release of Scorecard (Focus of NQF Committee)

# **Developing the Scorecard**

- <u>At a minimum</u> the candidate measures should:
  - Map to one of the pillars and domains
  - Have some level of validation
  - Be recent
  - Be available for 25 or more states
  - Fill a gap area from Scorecard 1.0
- In addition, measures in the State Health System Performance pillar must be publicly reported

# CMS Process for Review & Feedback (Summer 2019 Release)

- Internal Center-wide discussions to identify candidate measures
- National Association of Medicaid Directors' Advisory Group provides feedback across all three pillars
- Non-state stakeholder listen sessions provide feedback to CMCS
- Internal CMS discussions across other components to ensure alignment with broader CMS reporting activities
- Administrator review and sign off

### **Review of Voting Process**

#### **Voting on Measures**

- Committee members who recommend measures for discussion will be assigned as lead discussants during the inperson meeting
  - Lead discussants will introduce the measure, highlighting specifications and its value to the Scorecard
  - Lead discussants will liaise with measure developers to ensure availability during the meeting
- Ensuing discussions will include all Committee members
- Public comments will be solicited after Committee discussions
- After discussion of each measure and public comments, the Committee will vote on the measure

### **Decision Categories**

- Committee must reach a decision about every measure discussed
  - Each decision should be accompanied by one or more statements of rationale that explains why each decision was reached
- Decision categories include:
  - » Support
  - » Support with conditions
  - » Do not support
- Tallying the votes:
  - Quorum 66% of Committee required to be present for voting
  - ≥60% of votes denote the result of voting

### **Voting Decision Categories**

#### **SUPPORT**

- Ready for immediate use
- Relevant to all stages of life
- Outcome measures

#### **CONDITIONAL SUPPORT**

- Pending endorsement from NQF
- Pending CMS confirmation of feasibility

#### **DO NOT SUPPORT**

- Measure and/or measure focus inappropriate or a poor fit for the Scorecard
- Duplication of efforts
- Resource constraints
- State Medicaid agencies will need to tweak and/or vary the level of analysis to increase measure adoption and implementation
