Decisions and/or Recommendations

Approval of Innovation Accelerator Program (IAP) Program Area Measure Selection Process

The Coordinating Committee (CC) approved the process for selecting measures for recommendation in each of the four program areas: Reducing Substance Use Disorders, Improving Care for Medicaid Beneficiaries with Complex Care Needs and High Costs, Promoting Community Integration through Community-Based Long-Term Services and Supports, and Supporting Physical and Mental Health Integration. The measure selection process is a standardized approach through which the Technical Expert Panels (TEPs) will select the “best-available” measures in each program area to recommend to the CC. The selection process illustrates the criteria that the TEPs will utilize to review potential measures for recommendation. The process for selecting measures include the following steps:

1. **Scan Universe of Measures:** NQF staff uses various sources to search for relevant measures including, but not limited to, NQF-endorsed portfolio of measures, AHRQ's National Quality Measures Clearinghouse, CMS Measures Inventory, Healthcare Effectiveness Data and Information Sets, and measures utilized by select states.
2. **Capture Measures for Potential Inclusion in the Measure Sets:** NQF staff identify measures related to the goals and state activities in each program area. Staff captured measure details in the respective IAP program area measure summary sheets.
3. **Assign Rankings to Specific Measure Criteria:** NQF staff will allocate a ranking (e.g. high, medium, low) that reflects the feasibility, usability, scientific acceptability, and evidence base of each measure.
4. **Assign Overall Score to Each Measure:** NQF staff will assign a numeric value to each ranking to be used in the calculation of the overall measure score. The overall measure score is weighted by the criteria enumerated in step 3: feasibility and usability reflect 30% of the total score, scientific acceptability is 25% of the total score, and evidence is 15%.
5. **Conduct Initial Review:** Before the in-person meeting, the TEP members will review the staff measure suggestions, criteria used to rank the measures, and the total overall score assigned to each measure. Staff will incorporate the feedback prior to the TEP in-person meeting.
6. **Vote to Remove Measures by Measure Score:** During the in-person meeting, the TEPs will make preliminary recommendations for the removal of measures en bloc based on overall measure score within each CMS quality measurement domain.
7. **Analyze Measures to Recommend to the Coordinating Committee:** Also during the in-person meeting, the TEPs will evaluate the suitability of the remaining measures using a decision logic diagram. The decision logic queries the TEPs on whether a measure addresses the CMS quality objectives, provides an opportunity for quality improvement, is an efficient use of resources, is important to stakeholders, and if the measure is ready for implementation. Following the measure assessment, the TEPs will vote on whether or not to recommend the measure to the CC.

NQF staff will update the selection process based on feedback shared by the Coordinating Committee members.
