## Leadership Consortium Co-Chairs

## Peter Angood, MD, FRCS(C), FACS, MCCM, FAAPL (Hon)

President and CEO, American Association for Physician Leadership

Peter B. Angood, MD, FRCS (C), FACS, MCCM, FAAPL(Hon), has provided senior executive leadership for all sizes and types of healthcare organizations. Since 2011, he has been chief executive officer and president of the American Association for Physician Leadership; the only professional organization solely focused on leadership education and management training for the physician workforce. The organization has members in more than 45 countries.

Previously, Angood was first chief patient safety officer and a vice president for The Joint Commission where he oversaw the National Patient Safety Goals and other enterprise-wide, international patient safety initiatives. He also completed a two-year engagement with the National Quality Forum and National Priorities Partnership as Senior Advisor for Patient Safety before assuming the role of Chief Medical Officer with the Patient Safety Organization of GE Healthcare. During these engagements, Angood continued intermittent work with the World Health Organization (WHO) Patient Safety initiative after helping lead the early development of the WHO Collaborating Center for Patient Safety Solutions.

Earlier in his career, after initially practicing with hospitals of the McGill University system, Angood was subsequently recruited to surgery faculty and hospital administrative positions at the University of Pennsylvania, Yale University, and Washington University in St. Louis. He completed his formal academic career as a Full Professor of Surgery, Anesthesia, and Emergency Medicine. Angood is a Fellow of the Royal College of Surgeons (Canada), the American College of Surgeons and the American College of Critical Care Medicine, which also recognized him as a Master of Critical Care Medicine. He has a history of active involvement with numerous professional organizations and served as president of the Society of Critical Care Medicine. Angood's research interests have addressed leading-edge problems; he has authored nearly 200 publications and is a well-recognized international speaker on the host of issues related to physician leadership. Angood is also a Fellow of the Explorers Club in New York City.

Angood received his medical degree from the University of Manitoba in Canada and completed his general surgery training at McGill University in Montreal and fellowship training in trauma surgery and critical care medicine at the University of Miami/Jackson Memorial Hospital in Florida.

## Reena Duseja, MD, MS

Senior Advisor, Assistant Under Secretary for Health for Quality and Patient Safety, Veterans Health Administration (VHA)

Dr. Duseja serves as the Senior Advisor to the Assistant Under Secretary for Health for Quality and Patient Safety. In this position she provides expert advice on a full range of complex policy issues related to the formulation and establishment of effective health care policies, programs, and initiatives that

fulfill the VHA's mission to provide patient centered, data driven, evidenced-based, safe, high quality and efficient health care for Veterans.

Dr. Duseja is an emergency physician who has experience managing cross-cutting, complex initiatives in a variety of private and public settings. She most recently served as a White House Leadership Fellow at the Office of Management and Budget, where she led significant initiatives including helping standup the Safer Federal Workforce Taskforce and vaccine reporting for COVID-19 operations across federal agencies.

Prior to OMB, Dr. Duseja was at the Centers for Medicare and Medicaid Services (CMS), where she most recently served as the Chief Medical Officer of the Quality Measurement and Value-Based Incentives Group in the Center for Clinical Standards and Quality. In this role, Dr. Duseja provided leadership and oversight for the measure development and management of CMS's Medicare quality reporting and value-based purchasing programs, led alignment efforts in quality and cost measurement across the agency and interagency, developed innovative approaches to transform healthcare programs, and presented nationally on health care national priorities including value-based transformation.

Before joining federal service, Dr. Duseja was an Associate Professor of Emergency Medicine at the University of California, San Francisco (UCSF). There, she was a health services researcher, clinician, led quality improvement activities in a large county hospital, and funded by the National Institutes of Health to conduct studies related to improving patient care and value for the health system.

After making the unusual transition from Navy Nuclear Power electrician to nurse, he strived to translate the tenets of high-reliability organizations (HROs) that he learned on an aircraft carrier—the most rigorous of HRO environments—into healthcare. His work has contributed to understanding, measurement, and improvement of healthcare reliability, including:

- Epidemiology of nursing sensitive factors in intimate violence and suicidality,
- Development of clinical quality measures used nationally, and
- Evaluation of the effectiveness of healthcare delivery reported through measures and instruments, including studies of government-sponsored healthcare quality improvement incentive payment programs.

In addition to his primary role, Dr. Roberts currently holds volunteer leadership roles as the Immediate Past-President of HIMSS National Capital Area Chapter and as Vice Chair for the Institute of Electrical and Electronics Engineers Standards Association Engineering in Medicine & Biology Society P2795 Standard program. He also engages in research and improvement activities with the American Academy of Nursing's Informatics and Technology Expert Panel, which recently published
