#### **Anika Alvanzo, MD, MS**

Baltimore, Maryland

Anika Alvanzo, MD, MS, assistant professor at Johns Hopkins University, has clinical expertise in addiction medicine in both ambulatory and acute hospital settings. From 2011 to 2018, Dr. Alvanzo directed the Substance Use Disorders (SUD) Consultation Service, a multidisciplinary addiction consultation service providing clinical consultation, brief intervention, and treatment linkage services for inpatients with SUDs.
