Gerri Lamb, PhD, RN, FAAN

Associate Professor, Arizona State University Tucson, Arizona

Gerri Lamb, PhD, RN, FAAN co-chaired the former NQF Standing Committee on Care Coordination and is a nationally recognized expert in care coordination. She currently serves as subject matter expert on care coordination for the MAP Subcommittee on post-acute and long-term care. She is well known for her leadership and research on care coordination, case management, and transitional care. She has presented numerous papers and published extensively on the process and outcomes of care coordination in acute care, long-term care, and community settings.

Lee Partridge

Advisor, United Hospital Fund New York, New York

Lee Partridge has more than 35 years of experience in health policy and administration. In March 2016 she joined the child health staff of the United Hospital Fund and works with its grant initiative supporting New York City pediatric practices that screen their patients for social determinants of health and link families in need with appropriate community- based organizations. Her previous experience includes serving as health policy advisor to the National Partnership for Women and Families, where she specialized in performance measurement and quality improvement. She has been a consumer "voice" on several committees of the National Committee for Quality Assurance, including its Clinical Programs Committee and the advisory panels for its PCMH recognition program. She also served two terms as a member of the NQF CSAC. As the Director of the D.C. Medicaid program from 1983 to 1992 she was deeply engaged in efforts to address the AIDS epidemic, to reduce the city's infant mortality rate, and to relocate its developmentally disabled residents from institutional to community settings.

Christopher Stille, MD, MPH, FAAP

Professor of Pediatrics, University of Colorado School of Medicine; Section Head, Section of General Academic Pediatrics University of Colorado School of Medicine & Children's Hospital Aurora, Colorado

Christopher Stille, MD, MPH is Professor of Pediatrics and Section Head of General Academic Pediatrics at the University of Colorado School of Medicine and Children's Hospital Colorado. He leads a very active group of over 50 pediatric faculty, practices and teaches primary care pediatrics, and conducts pediatric health services research and quality improvement focused on improving systems of care for children and youth with special health care needs (CYSHCN) in the Medical Home. The primary focus of his

research has been improving communication and coordinated care for CYSHCN between primary care clinicians, subspecialists and family members. He has led projects funded by the U.S. Maternal and Child Health Bureau (MCHB), the Robert Wood Johnson Foundation, local and regional funders to pursue this investigation. Most recently, he became Principal Investigator of a MCHB-funded national network to conduct health systems research for CYSHCN. Dr. Stille is a member of the Executive Committee of the Council on Children with Disabilities of the American Academy of Pediatrics, and has been a member of several expert panels convened by the U.S. Maternal and Child Health Bureau on topics including establishing an evidence base for the Medical Home and access to pediatric specialty services for CYSHCN.

Debra Saliba, MD, MPH is the UCLA Anna and Harry Borun Endowed Chair in Geriatrics and Gerontology and Director of the UCLA/JH Borun Center for Applied Gerontological Research. Dr. Saliba is a practicing physician with the VA GRECC and serves as the Strategic Program Lead for Aging and Long-term Care populations in the VA HSR&D Center of Innovation. She is also a senior natural scientist at RAND. As a geriatrician and health services researcher, Dr. Saliba's research has focused on improving quality of life for vulnerable older adults across the care continuum. A major theme of this research has been the inclusion of patients and caregivers in health and need assessment. Dr. Saliba's research has included the development and testing of surveys of older adults' preferences, self-reported pain measurement, pressure ulcer and fall prevention, the development of quality measures, rejection of care behaviors, and both self-report and administrative data-based instruments to predict functional limitation and death. Dr. Saliba was principal investigator of the national research to revise the Minimum Data Set for Nursing Homes (MDS 3.0) for CMS and the VA. Items that relied on resident voice were introduced, reinforcing the goal of resident directed care. Dr. Saliba is Deputy Editor for the Journal of the American Geriatrics Society and past President and Board Chair of the American Geriatrics Society. She also serves on National Quality Forum MAP Workgroup on Post-Acute and Long-Term care quality and the CMS 5-Star TEP for Nursing Homes.

Ellen Schultz, MS (Inactive for Fall 2019 Cycle)

Senior Researcher, American Institutes for Research (AIR) Chicago, Illinois

Ellen Schultz is a Senior Researcher with the American Institutes for Research (AIR), specializing in quality measurement. Her work has focused on care coordination, clinical decision support, quality improvement, health care utilization, and quality measurement, including developing quality indicators related to patient safety, ambulatory care, lung cancer, home- and community-based services, hospital readmissions, and care coordination. Through my professional experience as a health care attorney representing multiple health care clients in the post-acute care continuum, as well as my personal experience as a bilateral amputee, I have extensive experience with policies involving rehabilitation and disability research, outcomes measurement, patient-centered care, the importance of functional (not just medical) status, quality of life, risk adjustment, and may other concepts. With bundled payment systems for rehab and post-acute care coming, we need good quality metrics so people with injuries, illnesses, disabilities and chronic conditions continue to have access to the appropriate setting of care and the appropriate intensity, duration, and scope of timely rehabilitation.
