Dr. Adelman is Chief Patient Safety Officer, Associate Chief Quality Officer, and Director of Patient Safety Research at New York-Presbyterian Hospital/Columbia University Medical Center. Professor of Pediatrics Sidney Kimmel/Thomas Jefferson Medical College and Professor emeritus, Nemours Children's Health System, Lewes, DE

Dr. Stephen Lawless, Professor of Pediatrics at Sidney Kimmel/Thomas Jefferson Medical College and emeritus at the Nemours Children's Health System, is an international expert and innovator in the field of quality, safety, infection control, risk, accreditation, credentials, academic affairs, and human subjects' protection. He also serves on the Boards of Medical Licensure and Discipline and Health Information Network for the State of Delaware. Dr. Lawless is an accomplished author and reviewer and serves on multiple journal editorial boards and national safety groups.

Lisa McGiffert, BA

Patient Safety Action Network Austin, TX

Lisa McGiffert is a co-founder of the Patient Safety Action Network, a nonprofit coalition focused on and with patients to raise awareness and to create accountability and transparency for safer healthcare. She retired as the Director of the Consumer Reports Safe Patient Project in 2018. This national project covered state and federal policies to end medical harm. Beginning in 2003, she led a campaign that developed model legislation that initiated state laws to publish hospital infection rates and raise public awareness about the problem. This highly successful effort led most states and CMS to require infection reporting. Lisa McGiffert's other policy expertise includes physician accountability; antibiotic resistant infections and antibiotic overuse; and improving the safety of medical implants. For 15 years, the Safe Patient Project collaborated with individuals who have experienced medical harm and their loved ones to change policies to improve patient safety. This network of advocates continues their work through the Patient Safety Action Network.

Lisa McGiffert routinely speaks on patient safety issues at conferences and with the media. She lends her expertise on numerous state and national advisory committees. In 2015, she was listed on *Modern Healthcare's* 100 Most Influential People in HealthCare and was given the Ben Shimberg Award by the Citizens Advocacy Center for her work on physician accountability. In 2016, 2017, and 2018, she was named by Becker's Hospital Review as one of 50 experts leading the field of patient safety. In 2018, she was awarded the Lewis Blackman Patient Advocate award, the Peggy Lillis Foundation Advocate Award, and named a "Hero of the Week" by The Bleeding Edge documentary film. From 1991-2003, Lisa McGiffert directed advocacy for Consumers Reports on the full array of health issues in Texas including access to care, health system reform, health insurance, physician and hospital regulation, and measuring quality of care. Prior to joining Consumer Reports, Lisa was a Policy Analyst/Legislative Director for the Texas Senate Committee on Health and Human Services where, for seven years, she was actively involved in the development and implementation of state policies.

Susan Moffatt-Bruce, MD, PhD, MBA, FACS

Dr. Susan Moffatt-Bruce is the Executive Director of University Hospital at Ohio State University's Wexner Medical Center. In this role, Dr. Moffatt-Bruce is responsible for overseeing the quaternary medical facility that is the flagship institution for The Ohio State University Health System. She

previously served as the inaugural Chief Quality and Patient Safety Officer for OSU. She is also a practicing cardiothoracic surgeon and a Professor of Surgery and Biomedical Informatics at the Ohio State University.

Director, Drug Safety, Island Peer Review Organization (IPRO) Lake Success, NY

Anne Myrka is the Senior Director of Drug Safety in the Health Care Quality Improvement Program at IPRO, the Centers of Medicare & Medicaid Services (CMS) designated Quality Innovation Organization (QIO) for New York State, New Jersey, and Ohio. In this role she leads the CMS QIO program for the state of Ohio and is also the lead for patient safety and drug safety tasks across the three states such as reducing opioid-related adverse drug events (ADEs) and deaths, reducing ADEs due to anticoagulants, diabetes medications, antibiotics and antipsychotics, reducing hospitalizations and readmissions due to ADEs, and reducing C. difficile infections in the community and nursing homes. Activities pertinent to NQF measure projects include developing evaluation metrics and working closely with IPRO epidemiologists to define and create measure specifications aligned with CMS goals and deliverables. Previous projects included the development of a hybrid eCQM measure for CMS deliverable that used data derived from hospital electronic health records and Medicare claims to identify high-risk medication ADEs that resulted in readmissions.

Ms. Roney is a nurse leader dedicated to patient safety and quality care. Her nursing career includes service to our country in the U.S. Army Reserves. Her nursing practice includes work in acute care settings in West Texas. She is active in local and national nursing organizations including the American Association of Critical Care Nurses and Sigma Theta Tau International. She has taught multiple continuing education programs on safety-related topics including CMS core measures, IHI bundles, and identification and management of the septic patient.

Dr. Yealy leads faculty delivering care to over 950,000 patients at UPMC and the University of Pittsburgh.

Yanling Yu, PhD

Physical Oceanographer and Patient Safety Advocate, Washington Advocate for Patient Safety Seattle, WA

Dr. Yanling Yu is a physical oceanographer and patient safety advocate. Before her retirement from University of Washington, she researched polar sea ice and their changes in response to climate change. However, her professional path took a sharp turn after her father tragically died due to preventable medical harm caused by the negligent use of an off-label medication. Now she is actively involved with various patient safety issues at the state and national levels. As a patient safety advocate, she promotes hospital care and medication safety, healthcare accountability and transparency, patient rights to informed consent and shared decision making, as well as patient- and family-centered care. In 2011, she and her husband Rex Johnson worked with state legislators and got a medical board transparency bill passed in Washington State. She will continue to be the voice for patients and families including those who have no voices anymore.
