The CSAC will review recommendations from the *Patient Safety* project at its November 18<sup>th</sup> in-person meeting. This serves as an addendum to the previous memo and contains the updated voting results as of the ending of the NQF member voting period on November 13<sup>th</sup>, 2015.

### NQF MEMBER VOTING RESULTS

All of the recommended measures were approved with 67 % approval or higher. Representatives of 44 member organizations voted; no votes were received from the Public/Community Health Agency Council.
