Dr. Jennifer Bailit is a tenured Professor of Reproductive Biology at Case Western Reserve University (CWRU). Within the MetroHealth System, Dr. Bailit serves as the Physician Executive for the Provider enterprise. Additionally, she is the Medical Director for the Women and Children's service line. Dr. Bailit did her undergraduate work at Brown University and her medical school at Tufts School of Medicine. A native of New England, Dr. Bailit was recruited to Cleveland, CWRU, and MetroHealth 18 years ago following her maternal-fetal medicine (MFM) fellowship, Robert Wood Johnson clinical scholar's program, and advanced training in public health at the University of North Carolina, Chapel Hill. Dr. Bailit's passion is to measure and improve the quality of care and outcomes for obstetric patients and newborns. Her published research on complications of pregnancy and adverse neonatal outcomes has focused on these patient factors as well as policy forces and costly decisions made by physicians that may adversely affect newborns' outcomes—including avoidable c-sections, nonmedically indicated iatrogenic deliveries, and failure to prescribe medications that could favorably affect perinatal outcomes. She is the Principal Investigator on the National Institute of Child Health and Human Development's (NICHD) Maternal-Fetal Medicine Research Network for the MetroHealth Center. Additionally, she was co-PI on the MFMU APEX trial looking to create quality measures and has had multiple publications from this dataset. In recognition of her work, she has been invited to provide expert counsel and serve on national and statewide standards-setting bodies, including appointment to Leap Frog, Re-Vitalize, and the Quality and Safety Committee of the Society for Maternal-Fetal Medicine.

**Amy Bell, DNP, RNC-OB, NEA-BC, CPHQ**

Dr. Amy Bell is the Director of Quality for Women's and Children's Services and Levine Cancer Institute for Atrium Health formally known as Carolinas HealthCare System (CHS), and has worked for the system for 23 years. She has 19 years of obstetrical experience, with 10 years in the nurse manager role and six years of experience in quality improvement. maternal morbidity and mortality on a global scale.
