



# Person-Centered Planning and Practice Committee Web Meeting 4 Summary

The National Quality Forum (NQF) convened the Person-Centered Planning and Practice Committee for a web meeting on September 6, 2019.

### **Welcome and Review of Meeting Objectives**

Kate Buchanan, NQF Senior Project Manager, welcomed the Committee and reviewed the following meeting objectives:

- Update on environmental scan and literature review
- Present final core competencies of people performing PCP facilitation
- Committee and public input on final core competencies

Co-chairs Gretchen Napier and Cheryl Phillips introduced themselves and provided welcoming remarks to the Committee, Committee liaisons, and the general public.

Ms. Buchanan updated the Committee members and liaisons on the amended process for the final report. Previously, several members and liaisons expressed concern over their roles in finalizing the report. NQF worked closely with federal partners to ensure that all members and liaisons have equitable roles. During the final web meeting, staff will ask for any concluding comments from each Committee and liaison member to strengthen the report. During this time, the Committee members and liaisons will sign off on the report.

Ms. Buchanan stated that the interim report will be posted for a 30-day public comment period: November 1 – December 2, 2019. Committee members are encouraged to hold listening sessions with advocacy groups as well as send the draft report to their networks for comment. Committee members will be able to comment on the interim report on the Committee SharePoint site during the public commenting period. During the December 13 web meeting, the Committee will adjudicate comments on the report as well as report out on their listening sessions. Ms. Buchanan clarified that listening sessions should be held outside of the formal process and that NQF staff cannot provide support. Staff will create a question guide to aid members and liaisons as they conduct the listening sessions. All of this will be communicated in an email to the Committee and liaisons prior to the public comment period.

#### Recap of Web Meeting 3

Ms. Buchanan provided highlights of the Committee's work during its last web meeting. The Committee members and liaisons discussed potential solutions on how to address Committee concerns including:

- Set time aside at the beginning of each call for general questions and comments
- Enlist members to engage in listening sessions to get feedback on the draft report
- Ask members to send the draft report to their respective networks for comments

Structure Committee feedback questions in a way that encourages broader feedback

The Committee refined core competencies of people performing PCP, discussed additional sources identified for PCP performance measures, and recommended approaches on how to conduct a historical review of PCP within long-term service and supports (LTSS) settings.

#### **Draft Definition of Person-Centered Planning**

The Committee has previously provided feedback on a definition of person-centered planning and practice and spent a portion of web meeting 4 further refining the definition.

The purpose of the definition is to inform the development of competencies for practice as well as for making recommendations on systems and organizational characteristics that support person-centered thinking, planning, and practices. This was accomplished by expanding the consensus-based PCP definition developed by the <a href="NQF HCBS Quality Committee">NQF HCBS Quality Committee</a> that focused on measure development. NQF staff also drew upon several PCP definitions from multiple sources, such as the CMS' HCBS Final Rule and Long-Term Care rule and other sources of federal guidance. Staff then conducted a literature search of peer reviewed and grey literature as well as state Medicaid websites to identify common elements of PCP definitions. These were grouped, synthesized, and presented to the Committee for discussion in previous web meetings.

During web meeting 4, the Committee pointed out themes related to their suggestions for improvements in the definition, emphasizing the need for plain language that people receiving LTSS can easily understand. Committee members agreed to continue to refine the definition via email.

#### Final Core Competencies for Person-Centered Planning Facilitation

Some states participating in Medicaid have asked for federal guidance on core competencies necessary to facilitate person-centered planning. NQF staff developed an initial list of core competencies for person-centered planning facilitation. The Committee discussed these core competencies during web meetings 2 and 3. NQF staff derived the initial list from an environmental scan of 28 PCP facilitation approaches. Staff presented the Committee with a generalized model for core competencies in HCBS, including shared decision making and potential transitions between LTSS settings and acute settings. Given the breadth and depth of person-centered planning across all areas of healthcare and LTSS delivery, NQF staff encouraged a discussion of multiple tiers or levels of intensity and skills needed to facilitate person-centered planning processes as medical and LTSS needs increase.

During web meeting 4, the Committee made minor adjustments and additions to core competencies found in five domains:

- Foundational skills
- Relational and communication skills
- Philosophical understanding
- Resource knowledge
- Policy and regulatory context

The Committee discussion and revisions will continue until an initial draft of the interim report is completed.

## Draft Recommendations for System Characteristics that Support Person-Centered Thinking, Planning, and Practice

Following the presentation on the draft definition, core competencies, and systems characteristics for person-centered planning, Debjani Mukherjee, NQF Senior Director, provided the Committee with draft recommendations for systems characteristics for consideration, discussion, and refinement. The characteristics were grouped into categories which are presented below along with Committee input for each:

- 1. Global characteristics that apply to every category:
  - Need to acknowledge the necessity to align all characteristics with outcomes
  - A Committee member noted that state Medicaid LTSS and HCBS programs share the same staff, so no need to tease out characteristics specific to HCBS and LTSS
- 2. System characteristic: Process
  - This section encompasses operational processes
  - Quality assurance and quality improvement processes for HCBS and other LTSS settings
- 3. System characteristic: Infrastructure
  - Affordable and appropriate housing
  - Support for innovation
- 4. System characteristic: Data
  - · Evidence-based meaningful data
  - Open-ended question-based data
  - Utilization management
- 5. System characteristic: Resources
  - Effective use and implementation of resources should be captured as data
  - Advocacy resources
  - Legal resources

The Committee discussion and revisions will continue for this section until an initial draft of the interim report is completed.

#### **Public Comments**

NQF received numerous public comments, which are summarized below.

- Members of the public offered numerous ideas on how to refine the draft definition of person-centered planning:
  - Add cultural humility and responsiveness
  - o Either make the definition shorter or break it down into bullet points
  - o Replace "residence" with "home"

- Provide definition in a language understood by the people it is designed to represent. The definition should be presented in plain (4th – 6th grade) language.
- o Remove the word "facilitated" in line one. Some individuals will run their own plan and do not need people to facilitate it for them.
- Break the definition down into subcategories such as mission, values, essential components, and ideals
- Add "planning for transition" regarding moving from different sites, level of care, providers, etc.
- Public commenters provided potential new competencies including:
  - Self-advocacy skills (foundational skills)
  - Understanding the individual's desire to either be addressed with person-first language or identity-first language
  - o Understanding behavior as communication (relational and communication skills)
  - Adding "patience" as a subcategory of "empathetic listening" (relational and communication skills)
  - o Transparency (relational and communication skills)
  - Being respectful (relational and communication skills)
  - Defining how to communicate to individuals, settings, and other stakeholders when an individual's personal plan is changed or updated (relational and communication skills)
  - Conflict management and mediation (relational and communication skills)
  - Culturally aware approaches to communication (relational and communication skills)
- Members of the public recommended the following changes to language used within the core competencies:
  - Using "biopsychosocial wellness" instead of "recovery" (philosophy)
  - Replace "recovery" with "living one's best life" (philosophy)
  - Replace "create a culture of high expectations" with "create a culture of realistic expectations" (foundational skills)
- Public commenters provided potential new system characteristics including:
  - Expectations for how and when person-centered plans get updated and disseminated (infrastructure)
  - Use process and outcome data to monitor person-centered planning (data)
  - Validate the importance of sharing data to all stakeholders connected to the individual (data)
  - o Advocacy and legal resources should be added to the resources category
  - Emergency/disaster preparedness and prioritization (resources)

#### **Next Steps**

Yvonne Kalumo-Banda, NQF Project Manager, shared that the interim report will include the draft definition of person-centered planning, the draft of core competencies of people performing person-centered planning facilitation, and the draft recommendations for system characteristics that support person-centered thinking, planning, and practice. The interim report will be posted for a 30-day public comment period beginning November 1 and closing December 2, 2019.
