### **Review of February FTG Homework Assignment**

- Focus Areas:
  - Element 3- An Organizational Planning and Priority-Setting Process
  - Element 5-An Agreed-Upon, Prioritized Set of Health Improvement Activities

- Stakeholder Involvement in Priority Setting
  - Some FTGs convened stakeholders in new organizational structures
  - Others FTGs accessed stakeholder organizations already existing in their communities
  - Examples of community data collected:
    - » Survey responses, interviews, focus groups, and public forums, influencing the priorities and goals set by the stakeholder groups
  - Transparency: most FTG stakeholders meet regularly
    - » Some adhered to a formal process of strategic planning
    - » Others allow their regular meetings to facilitate priority setting
  - Various document sharing and communication technologies were used, promoting trust and further transparency between members

### Priority Setting Approach

- Some FTGs followed a structured process
- Others took a more organic approach, engaging community members and coalition partners
- Specific approaches included:
  - » Strategy grid, multi-voting technique, stakeholder rankings, literature review/expert guidance on evidence-based solutions
- Regard for national priorities was common, such as the National Quality Strategy and Healthy People 2020
- Frameworks include:
  - Quality Strategy Toolkit, Collective Impact model, tools developed by NACCHO, County Health Rankings and Roadmaps Action Cycle, "Bigger Game" model from Rick Tamlyn

- Evaluation of Planning Effectiveness and Priority Setting Impact
  - Some FTGs still developing, but plan to incorporate some type of evaluation plan to track work
  - Examples of specific approaches used include:
    - » Plan-Do-Study-Act (PDSA) cycle
    - » SWOT analysis
  - Most FTGs have chosen measures/metrics for evaluation, or plan to do so in the near future
  - Some FTGs also plan to survey stakeholders and will track progress against prior evaluations

- Strategies for Developing and Managing "Asks"
  - FTGs often develop "asks" of stakeholders based on aligned goals relevant to specific partner organizations, and considering available resources
  - FTG health improvement activities are wide-ranging and generally projectspecific; examples include:
    - » Improving access to care
    - » Support efforts to integrate physical and behavioral health
    - » Access to "whole person" support, such as increased affordable housing and food security
    - » Education and training to reduce substance abuse
    - » Enhanced data management/IT infrastructure

### Draft Measure Chart

- As part of this project, a measure chart is being created to capture the key measures/indicators used by the FTGs
- Measures from several major initiatives focused on the health of populations are also included to allow comparisons:
  - County Health Rankings
  - Healthy People 2020 Leading Health Indicators
  - Medicare Shared Savings Program (MSSP)
  - Public Health Accreditation Board (PHAB)
