# **Thomas McInerny, MD**

Professor of Pediatrics, American Academy of Pediatrics Rochester, New York

Thomas K. McInerny, MD, FAAP, President of the American Academy of Pediatrics, is the Associate Chair for Clinical Affairs and Professor of Pediatrics at the University of Rochester Medical Center/Golisano Children's Hospital. Dr. McInerny is a graduate of Dartmouth College, Dartmouth Medical School, and Harvard Medical School. His pediatric residency training was at Cincinnati and Boston Children's Hospitals. He has over 30 publications in peer reviewed journals and is the editor-in-chief of the American Academy of Pediatrics "Textbook of Pediatric Care" and "Pediatric Care Online". He is currently serving as President of the American Academy of Pediatrics.

## Amir Qaseem, MD, PhD, MHA

Director, American College of Physicians West Philadelphia, Pennsylvania

Dr. Qaseem is responsible for leading the American College of Physicians' evidence-based medicine and clinical practice guidelines program, , one of the oldest programs in the United States, including writing of the clinical guidelines, and overseeing the College's Clinical Guidelines Committee. Dr. Qaseem is also in charge of directing the ACP's Performance Measurement program and is responsible for ACP's Performance Measurement Committee. He also leads the High Value Care Task Force evaluating and publishing the benefits, harms, and costs of various diagnostic tests and therapeutic interventions. Dr. Qaseem's work includes development and implementation of ACP's quality improvement and educational programs. Dr. Qaseem is also involved in several international collaborations to develop joint clinical guidelines and improve quality of care across different countries. Dr. Qaseem is also on governance boards and committees of various national and international organizations.

#### John Auerbach, MBA

President and CEO, Trust for America's Health Washington, District of Columbia

John Auerbach is president and CEO of TFAH, where he oversees the work to promote sound public health policy and make disease prevention a national priority. Over the course of a thirty-year career he has held senior public health positions at the federal, state, and local levels. As Associate Director at the Centers for Disease Control and Prevention (CDC) he oversaw policy and the agency's collaborative efforts with CMS, commercial payers, and large health systems. During his six years as the Commissioner of Public Health for the Commonwealth of Massachusetts, he developed innovative programs to promote health equity, combat chronic and infectious disease, and support the successful implementation of the state's health care reform initiative. As Boston's health commissioner for nine years, he directed homeless, substance abuse, and emergency medical services for the city as well as a wide range of public health divisions.

Mr. Auerbach was previously a professor of practice in health sciences and director of the Institute on Urban Health Research and Practice at Northeastern University; program director of one of the country's first community health centers; and director of a clinical training program at a tertiary care safety-net hospital.

Dr. Stoto received an AB from Princeton and a PhD from Harvard in Statistics, and is a Fellow of the American Statistical Association.
