She speaks frequently about the need for innovation in medical device data and technology, promoting data standards, device interoperability, and user platforms aimed at empowering patients to better manage their health. In addition, Anna is a vocal advocate for improving methods for comparative effectiveness research and the development of more refined outcomes measures to better guide care and assess treatments. He has served as a Liaison Committee on Medical Education Faculty Fellow, and as a member of the Internal Medicine Certifying Examination Writing Committee of the American Board of Internal Medicine, the New England Comparative Effectiveness Advisory Council, and the High Value Care Task Force of the American College of Physicians. Areas of interest include the periodic health examination, medical interviewing, communication about risk, cholesterol reduction, tuberculosis prevention, cancer screening, and the diagnosis of diabetes.

#### **Kimberly Templeton, MD**

Dr. Templeton is Professor of orthopaedic surgery at the University of Kansas Medical Center in Kansas City. In 2013, Dr. Templeton was elected to the National Board of Medical Examiners, after spending several years on various committees, task forces, and review committees. She serves as chair of the Sex and Gender Women's Health Collaborative a collaborative effort of the Society for Women's Health Research. In 2013, Dr. Templeton was named by the National Academy of Sciences to the musculoskeletal work group, reviewing and recommending new venues for sex and gender research for the National Aeronautic and Space Administration (NASA). Dr. Templeton is a past chair and current member of the Orthopaedic Section of the American Medical Association. Dr. Templeton is past-president of the Kansas State Board of Healing Arts and a member of several of its committees. She chaired a collaborative group of the various interested professional boards in Kansas to re-write the state's policy on chronic pain management. She currently sits on the advisory committee for the state's prescription drug monitoring program. Her research interests include women's health, medical education, and treatment of osteosarcoma.
