Marcia Ward, PhD

Director, Rural Telehealth Research Center, University of Iowa Iowa City, Iowa

Dr. Marcia M. Ward, PhD, is a professor in the Health Management and Policy Department and director of the Center for Health Policy and Research in the University of Iowa College of Public Health. Her research experience focuses on telehealth research, health services research, and rural healthcare delivery. She co-chaired the National Quality Forum (NQF) Committee on the Framework for Telehealth Measures. Dr. Ward directs the Rural Telehealth Research Center (RTRC), a consortium of researchers at the University of Iowa, University of North Carolina–Chapel Hill, and University of Southern Maine. RTRC is a HRSA-funded center to expand the evidence base for telehealth.

William Melms, MD

Chief Medical Officer, Marshfield Clinic Health System Marshfield, Wisconsin

Dr. Bill Melms currently serves as the chief medical officer for the Marshfield Clinic Health System (MCHS). In this role, he is responsible for overseeing all facets of patient-care and service delivery, overseeing a broad and diverse team of his fellow physicians and other service line executives. Furthermore, he is a clinical leader of the system's commitment to transitioning from a fee-for-service model to an organization that focuses on value-based care and innovation in care delivery. MCHS's 1,270 providers accommodate 3.5 million patient encounters each year across our nine hospitals and nearly 60 ambulatory clinical sites. MCHS's primary service area encompasses over 80 percent of the rural population of the state of Wisconsin, with over half of its facilities located in communties of less than 2,000 people.

Dr. Travis W. Austin, MA, MD, MPH is medical director of population health and palliative care and of home health at Summit Healthcare Regional Medical Center in Show Low, AZ. While attending medical school, Dr. Austin participated in the Rural Health Professions Program and completed rotations in Snowflake, AZ, and Indian Health Services on the Apache reservation. He did an emergency medicine residency at Dartmouth-Hitchcock and dedicated three extra years of training towards a unique combination of palliative care fellowship and preventive medicine residency. He is chair-elect of the Rural Special Interest Group of American Academy of Hospice and Palliative Medicine.

Susan Caponi, MBA, RN, BSN, CPHQ

Chief Executive Officer, ESRD Programs, IPRO Lake Success, New York

Susan Caponi, RN, BSN, MBA, CPHQ is CEO of IPRO's End-Stage Renal Disease (ESRD) Program, leading four CMS ESRD Networks that monitor the quality and safety of care provided to individuals with ESRD across 13 states. She previously directed the emergency and critical care services of a large hospital and implemented programs to educate employees on the value of a patient-centered approach. Ms. Caponi is a member of the National Kidney Foundation and the Forum of ESRD Networks. She has received numerous awards and accolades, including recognition from state and federal members of Congress, CMS, and the New York Times.

Dr. Haque has led public and private sector mixed-methods evaluations, policy analyses, and implementation support efforts.
