Project Name

- The National Quality Forum (NQF) has endorsed surgical measures through a variety of projects since 2004, beginning with the National Voluntary Consensus Standards for Cardiac Surgery
- Measures in this portfolio focus on outcomes for general and subspecialty surgical procedures including:
 - cardiac
 - orthopedic
 - ophthalmological
 - vascular surgeries and procedures; and
 - all phases of perioperative care
- The need to identify and endorse meaningful measures that will improve quality continues

Surgery Spring 2018 Review Cycle

- Two maintenance measures were submitted related to gynecologic surgery and 30-day mortality following CABG procedures
 - 2063 Performing cystoscopy at the time of hysterectomy for pelvic organ prolapse to detect lower urinary tract injury (American Urogynecologic Society)
 - 2558 Hospital 30-Day, All-Cause, Risk-Standardized Mortality Rate (RSMR) Following Coronary Artery Bypass Graft (CABG) Surgery (CMS/Yale CORE)
 - » Measure 2558 was reviewed by the NQF Scientific Methods Panel
- Both measures were recommended for endorsement

Public and NQF Member Comments Received

- NQF received nine comments from five member organizations
- All comments were supportive of the Committee's decision to recommend the measures for endorsement
- 2558: Hospital 30-Day, All-Cause, Risk-Standardized Mortality Rate Following Coronary Artery Bypass Graft Surgery (CMS/Yale CORE)
 - Additional comment suggesting the developer should perform empirical validity testing and explore the underlying relationship between factors like poverty or neighborhood deprivation on mortality
