Applications for the 2015 John M. Eisenberg Patient Safety and Quality Awards, presented by NQF and The Joint Commission, open September 8 and continue until October 30. quality. The 2014 Eisenberg winners include:

- Innovation in Patient Safety and Quality at the National Level: The American College of Surgeons for the National Surgical Quality Improvement Program (NSQIP), a nationally validated, risk-adjusted, outcomes-based program to measure and improve the quality of surgical care in participating hospitals.
- Innovation in Patient Safety and Quality at the Local Level: North Shore-LIJ Health System for results in reducing sepsis system-wide.

## Policy Highlights: Connecting You to Capitol Hill

Recent Congressional focus on improving healthcare quality, reducing costs, and increasing efficiencies has culminated in a flurry of legislative activity. Over the past month, both the U.S. House and Senate have taken up issues related to quality measurement, meaningful use of electronic health records (EHRs), the use and

expansion of telemedicine, and linking quality and cost. CMS is equally active, with several proposed rules released recently calling for comment. Here are just a few examples:

**Care Planning Act of 2015 (S. 1549).** On June 10, Senator Mark Warner (D-VA), introduced the bipartisan Care Planning Act (S. 1549), directed towards the coordination of care services for Medicare and other beneficiaries living with advanced illnesses. S. 1549 funds and prioritizes the development of quality measures focused on individual goals, preferences, and values of patients and their families. The bill also funds efforts to support and train individuals, families, and healthcare providers through the development of online training modules, decision support tools, and instructional materials.

**Medicare to Bundle Payments for Surgeries.** Secretary of Health and Human Services Sylvia Burwell announced in early July a plan to bundle payments for hip and knee replacement under Medicare, some of the most common surgeries received by the program's beneficiaries. Hospitals performing these surgeries will be eligible for a bonus payment or will be penalized based on the quality and efficiency of the surgery and the patient follow-up care post-discharge. The proposed rule is open for comment through September 8, 2015. This provision is included in the larger Medicare fee schedule proposed rule.

**CMS Proposes Rule to Change 2016 Medicare Physician Fee Schedule.** On July 8, CMS released the first proposed rule to update the physician payment schedule since the repeal of the sustainable growth rate through the Medicare Access and CHIP Reauthorization Act of 2015 (MACRA). The rule

includes provisions focused on person-centered care, efforts to shift the Medicare program toward a system that rewards physicians for providing high-quality care, and updates to payment policies. CMS also calls for comments on how to implement the Merit-based Incentive Program and the new alternative payments models called for in MACRA. The proposed rule is open for comment through September 8.

**Initial Star Ratings of Home Health Agencies Released.** CMS published for the first time its star ratings on Home Health Compare. The results are intended to help consumers compare and choose among home health agencies. More than 9,000 agencies were rated, with most receiving an average score, according to Kaiser Health News.
