NQF's Strategic Plan

During our Annual Conference, we announced the adoption of the 2016-2019 NQF Strategic Plan, a collaborative effort that has been championed, directed, and approved by the NQF Board. The plan answers an unmet need for NQF to lead, prioritize, and collaborate to drive measurement that can result in better, safer, and more affordable healthcare for patients, providers, and payers. At the same time, the plan aims to reduce the redundancy and cost of measurement.

The plan charts a new course for NQF that moves us from our current passive state of evaluation of submitted measures to a future dynamic state where we also lead and contribute to:

- Accelerated measure development
- Identification of priority measures and gaps
- Reducing measures
- Measure implementation
- Efforts to better understand what works and what doesn't in measurement

A key focus will be on filling important measure gaps through the newly launched **Measure Incubator**.

The plan also calls on us to identify the most important measures to improve U.S. healthcare. By identifying priority measures for the nation as well as for specific settings and populations, we can focus the quality community on the metrics needed to improve the quality, safety, and the affordability of care. This prioritization work holds promise to result in fewer, more meaningful measures.

NQF's newest Member Network kicked off in March with a presentation by Dr. Joseph Alvarnas, associate clinical professor, Department of Hematology & Hematopoietic Cell Transplantation and director of value-based analytics, at NQF Member organization, City of Hope.
