# Update on Fall 2021

## Fall 2021 Measure Overview

Measure Portfolio	Measures by Portfolio	Complex Measures (SMP Reviewed)	SMP Result
Geriatrics and Palliative Care	3	2	Both measures passed
Patient Safety	5	4	3 measures passed 1 measure passed on reliability and was CNR on validity
Primary Care and Chronic Illness	3	2	1 measure passed on reliability and was CNR on validity 1 measure deferred to spring 2022
Surgery	1	6	1 measure passed SMP 3 measures did not pass SMP 2 measures withdrew

## Fall 2021 Next Steps

- Standing Committees will hold measure evaluation meetings over the next couple months
  - ▣ Measure Developers with measures in the fall 2021 cycle should have received calendar invites for their respective project's measure evaluation meetings. Dates can also be found on the [NQF Calendar](#)
- After measure evaluation meetings, NQF staff will draft technical reports that summarize recommendations from each Standing Committee
- Reports are posted for a 30-day public and member commenting period
- Shortly after the close of the public and member commenting periods, the Standing Committees may reconvene for a post-comment web meeting
- After the post-comment web meeting, the CSAC will convene to make endorsement decisions on measures submitted to the fall 2021 review cycle

## Next Steps for Spring 2022

Following Intent to Submit on January 5:

- Complex measures are being reviewed by the SMP
  - ▣ Measure developers have been notified whether their measures are deemed complex and are being reviewed by the SMP
- Non-complex measures are being reviewed by staff
  - ▣ Completeness check feedback will be submitted to measure developers ahead of the full measure submission deadline
- Teams will reopen submissions for additional feedback as needed from developers
- Full submission deadlines are dependent on the topic area and can be found on the next slide

## SMP Next Steps for Spring 2022

- NQF SMP staff perform responsiveness checks on required ITS sections and communicate with developers about any necessary updates – *mid to late January*
- NQF SMP staff send measures to SMP for their preliminary review – *early February*
- NQF SMP staff send SMP preliminary analyses to developers to allow them the opportunity to respond and have the response included in the discussion guide for the measure evaluation meeting – *early March*
- NQF SMP staff notify developers of the measures being pulled for discussion at the measure evaluation meeting and the reason – *mid March*
- NQF hosts SMP measure evaluation meeting where SMP members review two groups of measures: those pulled for discussion and those measures that did not pass the preliminary review, for which a developer response was included in the discussion guide – *late March*
- NQF SMP staff sends results of the measure evaluation meeting to developers. This includes final voting results and determinations of eligibility for revote by the Standing Committees – *no more than 2 weeks after the SMP measure evaluation meeting*

If these change, please make updates in your measure submissions by using the Manage User Access function. NQF uses the contacts listed in the Dashboard to send updates and reminders about deadlines related to your measure.
- Measure Submission:
  - ▣ Seek technical assistance from NQF staff early and often. Measure submission deadlines are firm and extensions will not be granted. If you would like NQF staff to provide input on your draft submission, please contact the appropriate NQF project team and request technical assistance well in advance of the deadline
