Measure Review: Two Cycles Per Year

Consensus Development Process:

Two Cycles Every Contract Year





Consensus Development Process (CDP)

- Yearly Call for Nominations Complete
- Intent to Submit/Scientific Methods Panel (SMP) Review Fall 2020 Complete; Spring 2021 Ongoing
- Measure Evaluation Fall 2020 Ongoing; Spring 2021 Upcoming
 - Pre-meeting evaluation survey
 - Evaluation webinars/initial endorsement recommendations
- Commenting Fall 2020 Ongoing
 - Pre- and Post-commenting/Member Support
 - Draft Report posted during the last 30 days of commenting
 - Post-comment evaluation webinar/final endorsement recommendations
- Consensus Standards Approval Committee (CSAC) Review and Endorsement
- Appeals
 - Only for endorsed measures

Review of Measure Evaluation



Patient/Caregiver Measure Evaluation Tips

- Ask probing questions
 - It is ok not to understand
 - Asking probing questions encourages the measure developer to explain the measure in plain, everyday language and may assist your fellow committee members to better understand the measure
- Use your background and experiences as a patient or caregiver to express if a measure is important to you or not
 - Sharing your personal story can ground the discussion in the main goal of measurement: improving patient care
- Analyze the measure to the best of your ability and highlight areas of interest to you
 - Remember every member of the Standing Committee brings a different perceptive and your perceptive is an essential part of multistakeholder consensus
- Point out any measurement gaps you observe



Major Endorsement Criteria (page 32 in the SC Guidebook)

- Importance to measure and report (Evidence and Opportunity for Improvement): Goal is to measure those aspects with greatest potential of driving improvements; if not important, the other criteria are less meaningful (must-pass)
- Scientific acceptability of measure properties (Reliability and Validity): Goal is to make valid conclusions about quality; if not reliable and valid, there is risk of improper interpretation (mustpass)
- Feasibility: Goal is to, ideally, cause as little burden as possible; if not feasible, consider alternative approaches
- Use (must-pass for maintenance measures) and Usability: Goal is to use for decisions related to accountability and improvement; if not useful, probably do not care if feasible
- Comparison to related or competing measures

Honorarium Process



Honorarium

NQF recognizes the critical voice patient and caregivers have in driving measurable improvements in health and aims to mitigate financial barriers to patients and caregivers participating in NQF initiatives and ensure diversity in participation.



Honorarium Eligibility Criteria

- Participate as an individual whose own lived experiences bring meaningful perspective to the program or project
- Is not an employee of or paid by a participating organization
- Have not received any separate financial compensation or remuneration for their participation in the event or project, except for travel support paid directly by NQF
- Fully participate in the event or project, which typically includes at least 75% of an event's preparatory efforts and/or a project's meeting and calls
 - For CDP projects, that is at least 75% of two cycles

Up to \$1000/year for eligible representatives to be paid via an electronic funds transfer. Eligible candidates can apply on a yearly (or every 2 cycles) basis 18



Honorarium Application Process¹

- Upon completion of at least 75% of the project's meetings and calls, all patients and caregivers will be emailed an Honorarium application from the Patient and Caregiver Engagement mailbox
- Eligible patients and caregivers will have to complete their application form which includes an attestation of their eligibility, within 2-weeks of receipt
- Upon receipt of the Honorarium applications, CDP project teams will review the applications to ensure that applicants participated in at least 75% of the project's meetings and calls
- A decision will be communicated with the applicants no later than 3weeks after the Honorarium application is received.



Honorarium Application Process

- Honorarium applications that <u>do not meet</u> eligibility requirements will receive an email from their respective CDP project mailbox stating the reason why they were not approved
- Honorarium applications that <u>meet</u> eligibility requirements will be notified via the Patient and Caregiver Engagement mailbox that they have been approved and will be contacted by the NQF Finance Department who will provide a secure link to submit their W-9 form.

<u>Honorariums are taxable income and are reported to the Internal</u> <u>Revenue Service. NQF will send a 1099 form for filing your taxes by</u> <u>January 31st of the following year of when you were reimbursed.</u>
